Senate Amendment "A" to S. P. 103, L. D. 178, Bill "An Act to Regulate the Practice of Architecture and to Create a Board to Provide for the Examination and Registration of Architects."

---

Amend said bill by striking out in the 3rd line thereof the underlined words "R. S., c. 73-A, additional." and substituting in place thereof the following: 'Sec. 1. R. S., c. 73-A, additional.'

Further amend said bill by adding at the end of that part designated "Sec. 2.", the following paragraph:

**'Nothing contained in this chapter shall prohibit any person from performing or holding himself out as able to perform any and/or all the functions of an architect, provided that such person does not use the word "architect" or any derivative thereof in connection therewith.'**

Further amend said bill by adding at the end of that part designated as "Sec. 3." a new subsection to be numbered V, to read as follows:

**'V. Licensed real estate brokers duly registered as such, providing such persons do not use the word "architect" or any term derived therefrom.'**

Further amend said bill by striking out that section designated "Sec. 12."; and by renumbering sections 13 to 22, inclusive, to be numbered sections 12 to 21, inclusive.

Further amend said bill by striking out in the 3rd line of that part designated "**Sec. 18.**" after the word "**practice**" the underlined words: "**the profession of**"

Further amend said bill by striking out those sections designated as "**Sec. 23.**" and "**Sec. 24.**"; and by renumbering sections 25 and 26 to be numbered sections 22 and 23.

Further amend said bill by adding at the end thereof the following:

"**Sec. 2. R. S., c. 15, § 27, amended.** The 1st sentence of section 27 of chapter 15 of the revised statutes is hereby amended to read as follows: 'All money received by the treasurer of state from the board of registration in medicine, the board of registration of nurses, the board of examiners of applicants for admission to the bar, the board of accountancy, the board of veterinary examiners, the board of osteopathic examination and registration, the board of examiners of funeral directors and embalmers, the state board of registration and examination in optometry, the board of dental examiners, the state board of registration for professional engineers, **the state board of architects**, the state board of barbers and hairdressers, the examiners of podiatrists, and the board of commissioners of pharmacy shall constitute a fund, which shall be a continuous carrying account for the payment of the compensation and expenses of the members, the expenses of the board, and for executing the provisions of law relating to each board respectively, and so much thereof as may be required is appropriated for said purposes.' "
