STATE OF MAINE

IN THE YEAR OF OUR LORD NINETEEN HUNDRED
FORTY-NINE

AN ACT Relating to Old Age Assistance.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. R. S., c. 22, § 260, amended. The 3rd sentence of section 260 of chapter 22 of the revised statutes is hereby amended to read as follows:

'This assistance shall be sufficient, when added to all other income and support of the recipient, to provide such person with a reasonable subsistence compatible with decency and health, but not **less than \$60 per month and not exceeding ~~\$40~~ \$100** per month.'

Sec. 2. R. S., c. 22, § 260, amended. The last 2 paragraphs of section 260 of chapter 22 of the revised statutes, as enacted by section 1 of chapter 402 of the public laws of 1947, are hereby repealed.

Sec. 3. R. S., c. 22, § 261, sub-§ II, amended. Subsection II of section 261 of chapter 22 of the revised statutes, as amended by section 2 of chapter 402 of the public laws of 1947, is hereby further amended to read as follows:

II. Has not sufficient income or other resources to provide a reasonable subsistence compatible with decency and health ~~and such facts, together with statements including full information regarding income,~~

assets and liabilities, shall be sworn to in the application by the applicant;

Sec. 4. R. S., c. 22, § 261, sub-§§ V, VI, repealed. Subsections V and VI of section 261 of chapter 22 of the revised statutes are hereby repealed.

Sec. 5. R. S., c. 22, § 265, amended. The last 4 paragraphs of section 265 of chapter 22 of the revised statutes, as enacted by section 3 of chapter 402 of the public laws of 1947, are hereby repealed.

Sec. 6. R. S., c. 22, §§ 271, 272, repealed. Section 271 of chapter 22 of the revised statutes, as amended by section 2 of chapter 394 of the public laws of 1947; and section 272 of chapter 22 of the revised statutes, as amended by chapter 336 of the public laws of 1947, are hereby repealed.
