## STATE OF MAINE

#### IN THE YEAR OF OUR LORD NINETEEN HUNDRED FORTY-NINE

#### AN ACT to Incorporate the Town of Bay Point.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. Incorporation. All that portion of Bay Point, so-called, in the town of Georgetown, which is bounded and described as follows, viz.: Beginning at the southwest corner bound of the land now or formerly of Kenneth Dunlap; thence running southerly across the highway to the northwest corner bound of land now or formerly of Fred L. Andrews; thence southerly by said land now or formerly of Andrews to low water mark on the shore of Eels Eddy Bay; thence following the shore southerly, westerly, and northerly by low water mark of Eels Eddy Bay, Atlantic Ocean and Long Island Narrows to the southwest corner of land now or formerly of the heirs of John Warren; thence easterly by the southerly line of said land now or formerly of the John Warren heirs to the highway; thence easterly along the highway by land now or formerly of the John Warren heirs and land now or formerly of Elijah Spinney heirs to the point of beginning is hereby incorporated into a town, by the name of Bay Point; and the inhabitants thereof are hereby vested with all the powers, privileges and immunities, which the inhabitants of other towns within this state enjoy.

Sec. 2. Collection and payment of unpaid taxes. The present and past tax collectors of the town of Georgetown are hereby authorized, empow-

ered, and directed to collect and pay all unpaid taxes to them already legally committed and legally assessed under the provisions of section 5 and 10 of chapter 11 of the private and special laws of 1925, agreeably to their several warrants and the town of Georgetown shall pay over to the inhabitants of the town of Bay Point all taxes collected and not paid over or hereafter collected from past assessments made under the provisions of said sections 5 and 10.

Sec. 3. Payment of debts. The residents of the town of Bay Point and the non-resident proprietors thereof, as the case may be, shall be holden to pay the arrears of all taxes legally assessed and committed under the provisions of sections 5 and 10 of chapter 11 of the private and special laws of 1925. And the inhabitants of the town of Bay Point shall assume and pay all debts owed by Bay Point Village Corporation.

Sec. 4. Support of paupers. All persons who are, may or hereafter shall become chargeable as paupers and who have or shall have gained a legal settlement by residence upon the territory described in section I of this chapter shall be supported by the inhabitants of the town of Bay Point.

Sec. 5. Public buildings, released. The inhabitants of the town of Georgetown hereby releases to the inhabitants of the town of Bay Point all its right, title and interest in and to the public buildings in the territory described in section 1 of this chapter.

Sec. 6. Certain laws repealed. Chapter 11 of the private and special laws of 1925 and chapter 16 of the private and special laws of 1927 are hereby repealed; provided, however, that the corporate existence, powers, duties and liabilities of Bay Point Village Corporation shall survive for the purposes of prosecuting and defending all pending suits and causes of suits of which said corporation is, or may be, a party and all needful process growing out of the same, including provisions for the payment of any debts or judgments which may be rendered against said corporation or exist in favor of any creditor.
