STATE OF MAINE

IN THE YEAR OF OUR LORD NINETEEN HUNDRED FORTY-NINE

AN ACT Relating to the Augusta Game Preserve.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 33, § 128, amended. That part of section 128 of chapter 33 of the revised statutes, as revised, which relates to the Augusta game preserve, is hereby amended by adding at the end of the 1st sentence thereof the following :

'; Beginning at a point on the easterly side of the Loonville road and being 150 ft. more or less from the northerly side of the No. Belfast Ave. road, so called, and being the northwest corner of land now or formerly of Alphonse Darveau and known as the Anderson place, thence running northerly along the easterly side of said Loonville road about $1\frac{1}{2}$ miles more or less to a stake and stones marking the southwest corner of land of Clark Anderson, thence in an easterly direction to a stake and stone on the west side of Dam pond, thence continuing on an easterly direction across said pond to the westerly side of the Prescott road, so called, and marking the southwest corner of the Charles Evers lot, so called, continuing in an easterly direction along the southerly line of said Charles Evers lot to Stony brook, thence along southerly side of Stony brook to the westerly side of the North Belfast road, so called, thence in a southerly direction

along the westerly side of the North Belfast Ave. road to the intersection of the Prescott road and said North Belfast Ave. road, thence south, southwesterly along the northerly side of said No. Belfast Ave. road to the southeast corner of land now or formerly of Alphonse Darveau, thence in a northerly direction 50 ft. more or less, thence making an angle and running in a westerly direction along the northerly side of said Darveau's land about 200 ft. more or less along a stone wall to point of beginning.

Excepting a parcel beginning at intersection of Prescott road and North Belfast Ave. road and bounded as follows: On the east by the Prescott road, on the north by W. E. Reynolds' land, on west by one Charles Hisler and on the south by North Belfast road containing approximately 30 acres.

Also, excepting a small lot bounded on the east by North Belfast Ave. road, on the north by one Charles Hisler, on west by W. E. Reynolds, on south by Carrie Cunningham, containing about 4 acres.

Also, excepting a small parcel, bounded on north by one Hayden, on west by said Reynolds and on south by land of now or formerly of Harold Drew, on east by North Belfast Ave. road containing about $\frac{3}{4}$ of an acre.

Also, excepting a parcel of land bounded on north by Cunningham and Reynolds, on west by Reynolds, on the east and south by North Belfast road, containing 26 acres more or less.

The total acreage being 1,200 acres more or less. Said land being on the easterly side of the Loonville road and adjoining the Augusta game preserve on the east.'
