STATE OF MAINE

IN THE YEAR OF OUR LORD NINETEEN HUNDRED
FORTY-NINE

AN ACT Relating to Salaries of Somerset County Officers.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. R. S., c. 79, § 114, amended. That part of section 114 of chapter 79 of the revised statutes which relates to the salary of the clerk of courts of Somerset county, as amended by section 2 of chapter 280 of the public laws of 1945, is hereby further amended to read as follows:

'Somerset, ~~\$2,800~~ \$3,000.'

Sec. 2. R. S., c. 79, § 130, amended. That part of section 130 of chapter 79 of the revised statutes which relates to the salary of the county attorney of Somerset county, as amended by section 3 of chapter 280 of the public laws of 1945, is hereby further amended to read as follows:

'Somerset, ~~\$1,500~~ \$1,800.'

Sec. 3. R. S., c. 79, § 146, amended. That part of section 146 of chapter 79 of the revised statutes which relates to the salary of the county treasurer of Somerset county, as amended by section 4 of chapter 280 of the public laws of 1945, is hereby further amended to read as follows:

'Somerset, ~~\$900~~ \$1,000.'

Sec. 4. R. S., c. 79, § 165, amended. That part of section 165 of chapter 79 of the revised statutes which relates to the salary of sheriff of Somerset county, as amended by section 5 of chapter 280 of the public laws of 1945, is hereby further amended to read as follows:

‘Somerset, ~~\$2,000~~ \$2,200,’

Sec. 5. R. S., c. 79, § 231, amended. That part of section 231 of chapter 79 of the revised statutes which relates to the salary of the register of deeds of Somerset county, as amended by section 6 of chapter 280 of the public laws of 1945, is hereby further amended to read as follows:

‘Somerset, ~~\$2,100~~ \$2,300,’

Sec. 6. R. S., c. 140, § 3, amended. That part of section 3 of chapter 140 of the revised statutes which relates to the salary of the judge of probate of Somerset county, as amended by section 8 of chapter 280 of the public laws of 1945, is hereby further amended to read as follows:

‘Somerset, ~~\$2,000~~ \$2,100,’

Sec. 7. R. S., c. 140, § 22, amended. That part of section 22 of chapter 140 of the revised statutes which relates to the salary of the register of probate of Somerset county, as amended by section 9 of chapter 280 of the public laws of 1945, is hereby further amended to read as follows:

‘Somerset, ~~\$2,000~~ \$2,200,’
