## STATE OF MAINE

### IN THE YEAR OF OUR LORD NINETEEN HUNDRED FORTY-NINE

### RESOLVE, Providing for the Payment of Certain Damages Caused by Protected Wild Animals.

Damages caused by deer and moose to automobiles and crops, provided for. Resolved: That there be, and hereby is, appropriated the sum of \$21,545.27 from the funds of department of inland fisheries and game to be paid to certain persons, as a full and final settlement for their claims against the state for damages to their cars, trucks and crops according to the following list:
