COMMITTEE AMENDMENT "A" to H. P. 203, L. D. 125, Bill "An Act Amending the Charter of the Town of Dexter School District."

Amend said Bill by inserting after the enacting clause the following new section:

"Sec. 1. P. & S. L., 1949, c. 183, § 1, amended. Section 1 of chapter 183 of the private and special laws of 1949 is hereby amended to read as follows:

'Sec. 1. Incorporation; name; purposes. Subject to the provisions of sections 7 and 9 hereof, the inhabitants of and the territory within the town of Dexter are hereby created a body politic and corporate under the name "Town of Dexter School District", for the purpose of acquiring property within the said town for school and related athletic and recreational purposes: for the purpose of erecting, enlarging, repairing, equipping and maintaining on said property a school building or school buildings and related athletic and recreational facilities; for the purpose of maintaining elementary and secondary schools; fer-the-purpese ef-eempleting,-grading,-furnishing,-rebuilding,-renevating-ard etherwise-bettering-the-condition-of-any,-or-all,-buildings-within said-tewn-used-for-school-purposes-or-which-may-hereafter-be-used for seheol-purposes; for the purpose of leasing or letting any property of said district to said town; for the purpose of receiving, accepting and holding gifts, grants or devises of property real, personal or mixed to be used for school and related athletic and recreational purposes; all for the benefit of the inhabitants of said district."

Further amend said Bill by inserting at the beginning of the 1st line after the enacting clause the following underlined abbreviation and figure:

'Sec. 2.1

Further amend said Bill by striking out the underlined figures "\$400,000" in the last line before the Emergency clause and inserting in place thereof the underlined figures 1\$375,000'

Further amend said Bill by striking out, in the 5th line
