FIRST SPECIAL REPORT OF THE COMMITTEE ON APPORTIONMENT

In accordance with Senate Order No. 40, the Apportionment Committee presents this First Special Report to the 95th Legislature.

1. Resolves related to apportionment of Councillor Districts, Senatorial Districts and Congressional Districts, each resolve providing for a continuation of existing apportionments, have been reported to the Legislature and are now in possession of the Senate and House for legislative consideration.

2. With respect to House apportionment, the Committee agrees that the first step is a legislative determination of the allocation of 151 Representatives among the several counties. This determination should be made as promptly as may be in order that the apportionment changes, if any, within the several counties, may be done expeditiously and intelligently.

3. The Committee is not unanimous with respect to the question of allocations of Representatives among the counties, and the following members, by their signatures attached hereto, recommend the adoption of PLAN A, which would provide the following allocations:
