### IN THE YEAR OF OUR LORD NINETEEN HUNDRED FIFTY-ONE

## AN ACT Relating to Duties and Powers of Aroostook County Fire Marshal.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. R. S., c. 85, § 71, amended. The 4th sentence of section 71 of chapter 85 of the revised statutes, as enacted by chapter 227 of the public laws of 1949, is hereby amended to read as follows:

'He shall receive an annual salary of \$4,000 from the treasury of Aroostook county, in monthly payments paid on the last day of each month, and shall be paid his actual expenses incurred by him in the performance of his duties in an amount not to exceed \$2,500 such amount, not exceeding \$1,500 per year, as the county commissioners shall approve.'

Sec. 2. R. S., c. 85, § 72, additional. Chapter 85 of the revised statutes is hereby amended by adding thereto a new section to be numbered 72, to read as follows:

'Section. 72. Additional duties and powers. Such marshal shall, within Aroostook county, have the same powers and duties given to fire inspectors by virtue of the provisions of section 19; shall have the same powers and duties given the fire inspector by virtue of section 22; shall have the same powers and duties given to fire inspectors, boards of engineers and chiefs of

fire departments by virtue of sections 46, 47, 48 and 49, except that in case of conflict in authority between state, county and town fire officials, the order of final determination or decision shall be first in the state, second in the county and third in the town fire officials.'
