STATE OF MAINE

IN THE YEAR OF OUR LORD NINETEEN HUNDRED FIFTY-THREE

AN ACT Relating to Salaries of County Officers and Clerk Hire in Piscataquis County.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. R. S., c. 79, § 6, amended. That part of section 6 of chapter 79 of the revised statutes which relates to the salary of county commissioners of Piscataquis county is hereby amended to read as follows:

'Piscataquis, \$500 \$600,'

Sec. 2. R. S., c. 79, § 114, amended. That part of section 114 of chapter 79 of the revised statutes which relates to the salary of clerk of courts of Piscataquis county, as amended, is hereby further amended to read as follows:

'Piscataquis, \$1,800 \$2,200,'

Sec. 3. R. S., c. 79, § 130, amended. That part of section 130 of chapter 79 of the revised statutes which relates to the salary of the county attorney of Piscataquis county, as amended, is hereby further amended to read as follows:

'Piscataquis, \$900 \$1,500,'

Sec. 4. R. S., c. 79, § 146, amended. That part of section 146 of chapter 79 of the revised statutes which relates to the salary of the county treasurer in the county of Piscataquis, as amended, is hereby further amended to read as follows:

'Piscataquis, \$600 \$700,'

Sec. 5. R. S., c. 79, § 165, amended. That part of section 165 of chapter 79 of the revised statutes which relates to the salary of sheriff of Piscataquis county, as amended, is hereby further amended to read as follows:

'Piscataquis, \$1,800 \$2,200,'

Sec. 6. R. S., c. 79, § 231, amended. That part of section 231 of chapter 79 of the revised statutes which relates to the salary of register of deeds in Piscataquis county, as amended, is hereby further amended to read as follows:

'Piscataquis, \$1,800 \$2,200,'

Sec. 7. R. S., c. 79, § 269, amended. That part of section 269 of chapter 79 of the revised statutes which relates to clerk hire in county offices in Piscataquis county, as amended, is hereby further amended to read as follows:

'Piscataquis county: for clerks in the office of the register of deeds, \$1,820; for clerks in the office of register of probate, \$728 \$910; for clerks in the office of clerk of courts, \$1,820.'

Sec. 8. R. S., c. 140, § 3, amended. That part of section 3 of chapter 140 of the revised statutes which relates to the salary of judge of probate in Piscataquis county, as amended, is hereby further amended to read as follows:

'Piscataquis, \$1,200 \$1,800,'

Sec. 9. R. S., c. 140, § 22, amended. That part of section 22 of chapter 140 of the revised statutes which relates to the salary of register of probate in Pitcataquis county, as amended, is hereby further amended to read as follows:

'Piscataquis, \$1,600 \$2,000,'
