AN ACT Enlarging the Jefferson-Whitefield Game Preserve.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 33, § 128, amended. That part of section 128 of chapter 33 of the revised statutes, as revised, which relates to the Jefferson-Whitefield game preserve is hereby repealed and the following enacted in place thereof:

‘Jefferson and Whitefield: It shall be unlawful for any person to hunt, track, pursue, shoot at or kill any wild bird or wild animal at any time on or within the following described territory situate in the towns of Jefferson, Whitefield and Alna in the county of Lincoln, bounded and described as follows, to wit: Beginning at a point on the Old County road where a road extending from the Kings Mills to Alna highway intersects said Old County road near the property formerly owned by George Hausen; thence along said Old County road, sometimes known as the road leading from Weary Pond, in a southerly direction; thence in an easterly and southerly direction by property occupied by McKinnon to a point near the place formerly occupied by Scott Rankin; thence along that portion of the Old County road now abandoned to Puddle Dock; thence along the main highway in a southeasterly direction to the Egypt road, so called; thence along said Egypt road to route No. 215 leading from South Jefferson to Newcastle; thence in a northerly direction along said route No. 215 to a point

slightly north of the Trask meeting house where the Lincoln road, so called, intersects route No. 215 near the property of Maurice Weaver; thence along said Lincoln road in a westerly direction to a point slightly west of property occupied by George Pease; thence in a westerly and southerly direction along the Stearns Woods road, so called, to the point of beginning.

Notwithstanding the prohibition against hunting on the game preserve hereby created, the owner or occupant of any cleared and cultivated land lying within the boundaries of said game preserve may take or kill deer actually damaging any crop or fruit tree grown by him on said cultivated land in accordance with the provisions of subsection I of section 84 of this chapter.'
