**AN ACT Relating to Barbering, Hairdressing and Beauty Culture.**

---

Be it enacted by the People of the State of Maine, as follows:

**Sec. 1. R. S., c. 22, § 209, amended.** The last 2 paragraphs of section 209 of chapter 22 of the revised statutes are hereby amended to read as follows:

'No person, firm or corporation shall operate or cause to be operated a shop or establishment where barbering or hairdressing and beauty culture are practiced unless such shop or establishment has been duly licensed. The fee for a license to operate a barber shop shall be ~~\$5~~ **\$10** in the first instance and ~~\$3~~ **\$5** for each yearly renewal thereof. The license shall run from the 1st day of January in each year for 1 year and the fee shall be payable to the secretary of the board. The fee for a license to operate a beauty shop shall be ~~\$5~~ **\$10** in the first instance and ~~\$3~~ **\$5** for each yearly renewal thereof. The license shall run from the 1st day of July in each year for 1 year and the fee shall be payable to the secretary of said board.

Booths, attached to or within a beauty shop, that are operated independently thereof, shall be subject to license fees in the same manner as an independent shop. **Barber chairs, individually operated within a licensed**

**barber shop, may be subject to the fees provided in the same manner as an independent barber shop.'**

**Sec. 2. R. S., c. 22, § 217, amended.** The last sentence of the 1st paragraph of section 217 of chapter 22 of the revised statutes is hereby amended to read as follows:

'Said certificate of registration shall be renewed on or before the 1st day of January in each year, and the holder of said certificate of registration shall pay to the secretary of said board the sum of ~~§§~~ \$5 for said renewal.'

**Sec. 3. R. S., c. 22, § 217, amended.** The last 2 sentences of the 2nd paragraph of section 217 of chapter 22 of the revised statutes are hereby amended to read as follows:

'Said certificate of registration shall be renewed on or before the 1st day of July in each year, and the holder of said certificate of registration shall pay to the secretary of said board the sum of ~~§§~~ \$5 for said renewal. Certificate of registration limited to manicuring only may be issued upon complying with such examination requirements as may be determined by the board and upon payment of the fees as provided by sections 205 to 222, inclusive.'
