**AN ACT Relating to the Salaries of Various Officers in Waldo County.**

---

Be it enacted by the People of the State of Maine, as follows:

**Sec. 1. R. S., c. 79, § 6, amended.** That part of section 6 of chapter 79 of the revised statutes which relates to the salary of the county commissioners of Waldo county is hereby amended to read as follows:

‘Waldo, ~~\$500~~ \$1,000.’

**Sec. 2. R. S., c. 79, § 114, amended.** That part of section 114 of chapter 79 of the revised statutes which relates to the salary of the clerk of courts of Waldo county, as amended, is hereby further amended to read as follows:

‘Waldo, ~~\$2,250~~ \$2,400.’

**Sec. 3. R. S., c. 79, § 146, amended.** That part of section 146 of chapter 79 of the revised statutes which relates to the salary of the county treasurer of Waldo county, as amended, is hereby further amended to read as follows:

‘Waldo, ~~\$700~~ \$1,000.’

**Sec. 4. R. S., c. 79, § 231, amended.** That part of section 231 of chapter

79 of the revised statutes which relates to the salary of register of deeds of Waldo county, as amended, is hereby further amended to read as follows:

‘Waldo, ~~\$1,750~~ \$2,400,’

**Sec. 5. R. S., c. 140, § 3, amended.** That part of section 3 of chapter 140 of the revised statutes which relates to the salary of the judge of probate of Waldo county, as amended, is hereby further amended to read as follows:

‘Waldo, ~~\$1,750~~ \$2,400,’

**Sec. 6. R. S., c. 140, § 22, amended.** That part of section 22 of chapter 140 of the revised statutes which relates to the salary of the register of probate of Waldo county, as amended, is hereby further amended to read as follows:

‘Waldo, ~~\$1,750~~ \$2,400,’

**Sec. 7. R. S., c. 79, § 270, additional.** Chapter 79 of the revised statutes is hereby amended by adding thereto a new section to be numbered 270, to read as follows:

**‘Sec. 270. Fees in Waldo county. All fees for copies of any public or official documents or records, of whatever nature, and charges for the publication of notices required by law, which may be payable to any county officer, shall be payable to the treasurer of Waldo county for the use and benefit of the county.’**
