STATE OF MAINE

IN THE YEAR OF OUR LORD NINETEEN HUNDRED
FIFTY-THREE

AN ACT Relating to Hairdressing and Beauty Culture.

Be it enacted by the People of the State of Maine, as follows :

Sec. 1. R. S., c. 22, § 209, amended. The next to last sentence of the 3rd paragraph of section 209 of chapter 22 of the revised statutes is hereby amended to read as follows :

'The fee for a license to operate a beauty shop shall be \$5 in the first instance and \$3, **but not over \$5**, for each yearly renewal thereof.'

Sec. 2. R. S., c. 22, § 212, sub-§ I, amended. Subsection I of section 212 of chapter 22 of the revised statutes is hereby amended to read as follows :

'I. Who is at least ~~18~~ 16 years of age, **except that the actual practice of hairdressing and beauty culture shall not commence until such person is at least 17 years of age;**

Sec. 3. R. S., c. 22, § 214, amended. The 2nd paragraph of section 214 of chapter 22 of the revised statutes, as amended, is hereby further amended by inserting after the 1st sentence thereof the following new sentences :

'It shall be lawful, however, for students in said schools to become affiliated

with thairdressing or beauty culture shops and this may be done during the 1,500-hour training period set forth herein; but said affiliation shall not exceed 100 hours and is not compulsory. There shall be no salary compensation, but shops are allowed to pay for traveling expenses of the students. The supervision of the students shall be under the board. Upon receipt of a certificate from the shop owner, credit for the work done shall be given by the school towards the 1,500 hours of study.'

Sec. 4. R. S., c. 22, § 217-A, additional. Chapter 22 of the revised statutes, as amended, is hereby further amended by adding thereto a new section, to be numbered 217-A, to read as follows :

'**Sec. 217-A. Certificate renewal after 5 years.** No certificate to practice hairdressing and beauty culture, as set forth in sections 205 to 222, inclusive, shall be renewed after a period of 5 years unless said person has completed at least 30 hours of professional study at an accredited school or a Maine state convention, the same to be evidenced by a certificate.'
