**AN ACT Relating to Classification and Percentage Allocations for General Purpose Educational Aid.**

---

Be it enacted by the People of the State of Maine, as follows:

**Sec. 1. R. S., c. 37, § 201, amended.** The 4th paragraph of section 201 of chapter 37 of the revised statutes, as repealed and replaced by section 1 of chapter 386 of the public laws of 1951, is hereby amended to read as follows:

The range of classifications and the percentage allocations shall be as follows:

**Sec. 2. Appropriation.** There is hereby appropriated from the general fund the sum of \$14,000 for the fiscal year ending June 30, 1954, and the sum of \$14,000 for the fiscal year ending June 30, 1955 to carry out the purposes of this act.
