STATE OF MAINE

IN THE YEAR OF OUR LORD NINETEEN HUNDRED FIFTY-FIVE

AN ACT Increasing Salaries of Certain County Officials of Franklin County.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. R. S., c. 89, § 98, amended. That part of section 98 of chapter 89 of the revised statutes, which relates to the salary of the clerk of courts of Franklin county, is hereby amended to read as follows:

'Franklin, \$2,000 **\$2,100**,'

Sec. 2. R. S., c. 89, § 130, amended. That part of section 130 of chapter 89 of the revised statutes, which relates to the salary of treasurer of Franklin county, is hereby amended to read as follows:

'Franklin, \$900 **\$1,000**,'

Sec. 3. R. S., c. 89, § 149, amended. That part of section 149 of chapter 89 of the revised statutes, which relates to the salary of the sheriff of Franklin county, is hereby amended to read as follows:

'Franklin, \$2,200 **\$2,400**,'

Sec. 4. R. S., c. 89, § 215, amended. That part of section 215 of chapter 89 of the revised statutes, which relates to salary of the register of deeds of Franklin county, is hereby amended to read as follows:

'Franklin, \$1,700 **\$2,000**,'

Sec. 5. R. S., c. 89, § 254, amended. That part of section 254 of chapter 89 of the revised statutes, which relates to salaries for clerks in the offices of regis-

ter of deeds, register of probate and clerk of courts, for Franklin county, is hereby amended to read as follows:

'Franklin county: for clerks in the office of register of deeds, \$+,300 \$1,600; for clerks in the office of register of probate, \$000 \$700; for clerks in the office of clerk of courts, \$+,300 \$1,600.'

Sec. 6. R. S., c. 153, § 3, amended. That part of section 3 of chapter 153 of the revised statutes, which relates to the salary of the judge of probate, of Franklin county, is hereby amended to read as follows:

'Franklin, \$1,200 \$1,500,'

Sec. 7. R. S., c. 153, § 22, amended. That part of section 22 of chapter 153 of the revised statutes, which relates to the salary of the register of probate in Franklin county, is hereby amended to read as follows:

'Franklin, \$1,500 **\$1,800**,'

Sec. 8. Effective date. The provisions of this act shall be retroactive to January 1, 1955.
