# IN THE YEAR OF OUR LORD NINETEEN HUNDRED FIFTY-SEVEN

#### AN ACT to Increase Certain County Salaries in Somerset County.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. R. S., c. 89, § 6, amended. That part of section 6 of chapter 89 of the Revised Statutes which relates to the salary of county commissioners of Somerset county is hereby amended to read as follows:

'Somerset, \$1,000, except that the chairman of the board of commissioners shall receive \$1,200,'

Sec. 2. R. S., c. 89, § 98, amended. That part of section 98 of chapter 89 of the Revised Statutes which relates to the salary of the clerk of courts of Somerset county is hereby amended to read as follows:

'Somerset, \$3,500 \$4,000,'

Sec. 3. R. S., c. 89, § 114, amended. That part of section 114 of chapter 89 of the Revised Statutes which relates to the salary of the county attorney of Somerset county is hereby amended to read as follows:

'Somerset, \$2,500 \$3,500,'

Sec. 4. R. S., c. 89, § 130, amended. That part of section 130 of chapter 89 of the Revised Statutes which relates to the salary of the county treasurer of Somerset county is hereby amended to read as follows:

<sup>&#</sup>x27;Somerset, \$1,600 \$2,000,'

Sec. 5. R. S., c. 89, § 149, amended. That part of section 149 of chapter 89 of the Revised Statutes which relates to the salary of the sheriff of Somerset county is hereby amended to read as follows:

'Somerset, \$3,000 \$4,000,'

Sec. 6. R. S., c. 89, § 215, amended. That part of section 215 of chapter 89 of the Revised Statutes, as amended by chapter 324 of the public laws of 1955, which relates to the salary of the register of deeds of Somerset county, is hereby amended to read as follows:

'Somerset, <del>\$3</del>,<del>400</del> **\$4,000**,'

Sec. 7. R. S., c. 153, § 3, amended. That part of section 3 of chapter 153 of the Revised Statutes, which relates to the salary of the judge of probate of Somerset county, is hereby amended to read as follows:

'Somerset, \$3,000 \$4,000,'

Sec. 8. R. S., c. 153, § 22, amended. That part of section 22 of chapter 153 of the Revised Statutes which relates to the salary of the register of probate of Somerset county is hereby amended to read as follows:

'Somerset, \$2,600 \$3,000,'
