STATE OF MAINE

IN THE YEAR OF OUR LORD NINETEEN HUNDRED
FIFTY-SEVEN

AN ACT to Increase Certain County Salaries in Hancock County.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. R. S., c. 89, § 6, amended. That part of section 6 of chapter 89 of the Revised Statutes which relates to the salary of the county commissioners of Hancock county is hereby amended to read as follows:

'Hancock, ~~\$750~~ \$1,200.'

Sec. 2. R. S., c. 89, § 98, amended. That part of section 98 of chapter 89 of the Revised Statutes which relates to the salary of the clerk of courts of Hancock county is hereby amended to read as follows:

'Hancock, ~~\$2,600~~ \$3,000.'

Sec. 3. R. S., c. 89, § 149, amended. That part of section 149 of chapter 89 of the Revised Statutes which relates to the salary of sheriff of Hancock county is hereby amended to read as follows:

'Hancock, ~~\$3,000~~ \$3,500.'

Sec. 4. R. S., c. 89, § 215, amended. That part of section 215 of chapter 89 of the Revised Statutes which relates to the salary of the register of deeds of Hancock county, as amended by section 2 of chapter 327 of the public laws of 1955, is hereby further amended to read as follows:

'Hancock, ~~\$2,500~~ \$3,000.'

Sec. 5. R. S., c. 153, § 3, amended. That part of section 3 of chapter 153 of the Revised Statutes which relates to the salary of judge of probate of Hancock county is hereby amended to read as follows:

‘Hancock, ~~\$3,000~~ \$3,500.’

Sec. 6. R. S., c. 153, § 22, amended. That part of section 22 of chapter 153 of the Revised Statutes which relates to the salary of register of probate of Hancock county is hereby amended to read as follows:

‘Hancock, ~~\$2,500~~ \$3,000.’
