STATE OF MAINE

IN THE YEAR OF OUR LORD NINETEEN HUNDRED FIFTY-SEVEN

AN ACT Increasing Salaries of County Officers and Clerk Hire in Piscataquis County.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. R. S., c. 89, § 6, amended. That part of section 6 of chapter 89 of the Revised Statutes which relates to the salary of the county commissioners of Piscataquis county is hereby amended to read as follows:

'Piscataquis, \$600 **\$800**,'

Sec. 2. R. S., c. 89, § 98, amended. That part of section 98 of chapter 89 of the Revised Statutes which relates to the salary of the clerk of courts of Piscataquis county is hereby amended to read as follows:

'Piscataquis, \$2,200 **\$2,850**,'

Sec. 3. R. S., c. 89, § 114, amended. That part of section 114 of chapter 89 of the Revised Statutes which relates to the salary of county attorney of Piscataquis county is hereby amended to read as follows:

'Piscataquis, \$1,500 \$1,950,'

Sec. 4. R. S., c. 89, § 130, amended. That part of section 130 of chapter 89 of the Revised Statutes which relates to the salary of county treasurer of Piscataquis county is hereby amended to read as follows:

'Piscataquis, \$700 \$900,'

Sec. 5. R. S., c. 89, § 149, amended. That part of section 149 of chapter 89 of the Revised Statutes which relates to the salary of the sheriff of Piscataquis county is hereby amended to read as follows:

'Piscataquis, \$2,200 **\$2,850**,'

Sec. 6. R. S., c. 89, § 215, amended. That part of section 215 of chapter 89 and the Revised Statutes which relates to the salary of the register of deeds of Piscataquis county is hereby amended to read as follows:

'Piscataquis, \$2,200 **\$2,850**,'

Sec. 7. R. S., c. 89, § 254, amended. That part of section 254 of chapter 89 of the Revised Statutes which relates to the salary of clerks in Piscataquis county is hereby amended to read as follows:

'Piscataquis county: for clerks in the office of the register of deeds, \$7,820\$2,340; for clerks in the office of register of probate, \$910 \$2,340; for clerks in the office of clerk of courts, \$7,820 \$2,496.'

Sec. 8. R. S., c. 153, § 3, amended. That part of section 3 of chapter 153 of the Revised Statutes which relates to the salary of the judge of probate of Piscataquis county is hereby amended to read as follows:

'Piscataquis, \$1,800 \$2,350,'

Sec. 9. R. S., c. 153, § 22, amended. That part of section 22 of chapter 153 of the Revised Statutes which relates to the salary of the register of probate of Piscataquis county is hereby amended to read as follows:

'Piscataquis, \$2,000 **\$2,600**,'

Sec. 10. Effective date. The provisions of this act shall be retroactive to January 1, 1957.
