STATE OF MAINE

IN THE YEAR OF OUR LORD NINETEEN HUNDRED FIFTY-SEVEN

AN ACT Relating to Registration Fees for Motor Buses Used for Transportation of Passengers for Hire.

Be it enacted by the People of the State of Maine, as follows:

- Sec. 1. R. S., c. 22, § 16, sub-§ I, ¶ B, amended. Paragraph B of subsection I of section 16 of chapter 22 of the Revised Statutes is hereby amended by adding a new sentence following the 1st sentence to read as follows:
- 'Motor buses used for the transportation of passengers for hire in interstate or intrastate commerce, or both, by carriers granted certificates of public convenience and necessity, or permits by the Public Utilities Commission shall pay fees as scheduled in subparagraph 2 of paragraph C.'
- Sec. 2. R. S., c. 22, § 16, sub-§ I, ¶ C, sub-¶ 1, amended. Subparagraph 1 of paragraph C of subsection I of section 16 of chapter 22 of the Revised Statutes is hereby amended to read as follows:
 - '1. Operating under the provisions of chapter 48, or except motor buses used for the transportation of passengers for hire in interstate and intrastate commerce, or both, by carriers granted certificates of public conveyance and necessity, or permits, by the Public Utilities Commission, which shall pay fees as scheduled in subparagraph 2 of paragraph C.'
- Sec. 3. R. S., c. 22, § 16, sub-§ I, ¶ C, sub-¶ 2, amended. Subparagraph 2 of paragraph C of subsection I of section 16 of chapter 22 of the Revised Statutes is hereby amended by adding a new sentence following the 1st sentence to read as follows:

'Notwithstanding any other provision in this section, motor buses used for the transportation of passengers for hire in interstate or intrastate commerce, or both, by carriers granted certificates of public convenience and necessity, or permits, by the Public Utilities Commission shall pay the sum of 50c per seat.'
