# STATE OF MAINE

#### IN THE YEAR OF OUR LORD NINETEEN HUNDRED FIFTY-SEVEN

#### AN ACT Increasing the Salaries of Judges and Recorders of Municipal Courts in Kennebec County.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. P. & S. L., 1919, c. 75, § 13, amended. The first sentence of section 13 of chapter 75 of the private and special laws of 1919, as last amended by section 1 of chapter 149 of the private and special laws of 1947, is hereby further amended to read as follows:

'The compensation of the judge (Augusta Municipal Court) in full for all services <del>commencing January 1</del>, <del>1947</del> shall be <del>\$2,500</del> **\$2,900** per annum, payable monthly from the treasury of the county of Kennebec.'

Sec. 2. P. & S. L., 1919, c. 75, § 12, amended. The last sentence of section 12 of chapter 75 of the private and special laws of 1919, as last amended by chapter 126 of the private and special laws of 1955, is hereby further amended to read as follows:

'Said recorder (Augusta Municipal Court) shall be appointed for a term of 4 years, and until his successor has duly qualified, and as compensation in full for his services shall receive \$+,500 \$1,700 per year, payable by the county of Kennebec in the same manner as the salary of said judge.'

Sec. 3. P. & S. L., 1911, c. 247, § 10, amended. The first sentence of section 10 of chapter 247 of the private and special laws of 1911, as last amended by chapter 127 of the private and special laws of 1955, is hereby further amended to read as follows:

'The salary of said judge (Gardiner Municipal Court) shall be \$1,800 \$2,100 per year and the same shall be payable quarterly out of the treasury of the county of Kennebec, on the first day of January, April, July and October.'

Sec. 4. P. & S. L., 1911, c. 247, § 11, amended. Section 11 of chapter 247 of the private and special laws of 1911, as last amended by chapter 128 of the private and special laws of 1955, is hereby further amended to read as follows:

'Sec. 11. Salary of recorder. The said recorder (Gardiner Municipal Court) shall receive an annual salary of <del>\$900</del> **\$1,200**, and the same shall be payable quarterly from the treasury of the county of Kennebec, on the first day of January, April, July and October.'

Sec. 5. P. & S. L., 1897, c. 325, § 3, amended. Section 3 of chapter 325 of the private and special laws of 1897, as last amended by section 1 of chapter 104 of the private and special laws of 1953, is hereby further amended to read as follows:

'Sec. 3. Judge, salary; clerical assistance. Said court (Waterville Municipal) shall consist of 1 judge, to be appointed in the manner and for the term provided by the constitution, who shall be a member of the bar in Kennebec county, who shall reside during his continuance in office in said city of Waterville, and who shall receive from the county of Kennebec, in monthly payments, an annual salary of \$2,700 \$3,200, which shall be in full for all fees pertaining to his office; and he shall have the authority to employ such clerical assistance as is necessary, and the city shall pay therefor.'

Sec. 6. P. & S. L., 1897, c. 225, § 8, amended. The 2nd sentence of section 8 of chapter 225 of the private and special laws of 1897, as last amended by chapter 20 of the private and special laws of 1953, is hereby further amended to read as follows:

'The recorder (Waterville Municipal Court) shall receive from the treasurer of the county of Kennebec, in monthly payments, an annual salary of \$7,000 \$1,200, which shall be in full for all fees pertaining to his office.'

Sec. 7. P. & S. L., 1919, c. 61, § 3, amended. Section 3 of chapter 61 of the private and special laws of 1919, as last amended by chapter 33 of the private and special laws of 1953, is hereby further amended to read as follows:

'Sec. 3. Salary of judge; disposition of fees. The judge of said court (Winthrop Municipal) shall receive a salary of  $\$_{7,200}$   $\$_{1,600}$  yearly from the treasury of said county, payable quarterly, in full for all services, and all fees, civil and criminal, by him received shall be paid into the treasury of said county quarterly.'
