STATE OF MAINE

IN THE YEAR OF OUR LORD NINETEEN HUNDRED FIFTY-NINE

AN ACT Increasing Salaries of County Officers of Androscoggin County.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. R. S., c. 89, § 6, amended. That part of section 6 of chapter 89 of the Revised Statutes which relates to Androscoggin County, as amended by section 1 of chapter 416 and by section 77 of chapter 429, both of the public laws of 1957, is further amended to read as follows:

'Androscoggin, \$1,520 \$1,800, except the chairman of said board who, in addition to his regular duties, shall superintendent the county buildings, and for all his services his annual salary shall be the sum of \$2,180 \$2,400.'

Sec. 2. R. S., c. 89, § 98, amended. That part of section 98 of chapter 89 of the Revised Statutes which relates to the salary of the clerk of courts of Androscoggin County, as amended by section 2 of chapter 416 of the public laws of 1957, is further amended to read as follows:

'Androscoggin, \$3,700 \$4,200,'

Sec. 3. R. S., c. 89, § 114, amended. That part of section 114 of chapter 89 of the Revised Statutes which relates to the salary of the county attorney and assistant county attorney of Androscoggin County, as amended by section 1 of chapter 406 of the public laws of 1957, is further amended to read as follows:

'Androscoggin, \$3,700 \$4,200; assistant county attorney, \$2,960 \$3,200,'

Sec. 4. R. S., c. 89, § 130, amended. That part of section 130 of chapter 80 of the Revised Statutes which relates to the salary of the county treasurer of

Androscoggin County, as amended by section 3 of chapter 416 of the public laws of 1957, is further amended to read as follows:

'Androscoggin, \$3,700 \$4,200,'

Sec. 5. R. S., c. 89, § 149, amended. That part of section 149 of chapter 89 of the Revised Statutes which relates to the salary of the sheriff of Androscoggin County, as amended by section 4 of chapter 416 of the public laws of 1957, is further amended to read as follows:

'Androscoggin, \$4,250 \$5,000,'

Sec. 6. R. S., c. 89, § 215, amended. That part of section 215 of chaptre 89 of the Revised Statutes which relates to the salary of the register of deeds of Androscoggin County, as amended by section 5 of chapter 416 of the public laws of 1957, is further amended to read as follows:

'Androscoggin, \$4,200 \$5,000,'

Sec. 7. R. S., c. 153, § 3, amended. That part of section 3 of chapter 153 of the Revised Statutes which relates to the salary of the judge of probate of Androscoggin County, as amended by section 7 of chapter 416 of the public laws of 1957, is further amended to read as follows:

'Androscoggin, \$3,950 \$5,000,'

Sec. 8. R. S., c. 153, § 22, amended. That part of section 22 of chapter 153 of the Revised Statutes which relates to the salary of the register of probate of Androscoggin County, as amended by section 8 of chapter 416 of the public laws of 1957, is further amended to read as follows:

'Androscoggin, \$3,200 \$4,000,'
