**AN ACT Increasing Clerk Hire and Salaries of County Officers of
Cumberland County.**

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. R. S., c. 89, § 6, amended. That part of section 6 of chapter 89 of the Revised Statutes which relates to the salary of the county commissioners of Cumberland County, as last amended by section 18 of chapter 416 of the public laws of 1957, is further amended to read as follows:

'Cumberland, ~~\$3,500~~ \$4,000.'

Sec. 2. R. S., c. 89, § 98, amended. That part of section 98 of chapter 89 of the Revised Statutes which relates to the salary of the clerk of courts of Cumberland County and deputy clerk of courts as last amended by section 19 of chapter 416 of the public laws of 1957, is further amended to read as follows:

'Cumberland, ~~\$4,500~~ \$5,000; deputy clerk of courts, ~~\$3,800~~ \$4,200.'

Sec. 3. R. S., c. 89, § 130, amended. That part of section 130 of chapter 89 of the Revised Statutes which relates to the salary of the county treasurer and deputy treasurer of Cumberland County, as last amended by section 20 of chapter 416 of the public laws of 1957, is further amended to read as follows:

'Cumberland, ~~\$4,000~~ \$5,000; deputy treasurer, ~~\$3,500~~ \$3,800.'

Sec. 4. R. S., c. 89, § 149, amended. That part of section 149 of chapter 89 of the Revised Statutes which relates to the salary of the sheriff of Cumberland

County, as last amended by section 21 of chapter 416 of the public laws of 1957, is further amended to read as follows:

'Cumberland, ~~\$6,000~~ \$6,500.'

Sec. 5. R. S., c. 89, § 215, amended. That part of section 215 of chapter 89 of the Revised Statutes which relates to the salary of the register of deeds of Cumberland County, as last amended by section 1 of chapter 411 of the public laws of 1955, is further amended to read as follows:

'Cumberland, ~~\$4,500~~ \$5,000.'

Sec. 6. R. S., c. 89, § 254, amended. That part of section 254 of chapter 89 of the Revised Statutes which relates to Cumberland County, as last amended by section 22 of chapter 416 of the public laws of 1957, is further amended to read as follows:

'Cumberland County: for clerks in the office of register of deeds, ~~\$28,000~~ \$32,500; deputy register of deeds, ~~\$3,800~~ \$4,200; for clerks in the office of register of probate, ~~\$15,000~~ \$17,500; for clerks in the office of clerk of courts, ~~\$18,000~~ \$24,000; for clerks in the office of the recorder of the Portland municipal court ~~\$6,700~~ \$7,000; for clerks in the office of county attorney, ~~\$2,600~~ \$2,860; for clerks in the office of sheriff, ~~\$4,500~~ \$5,200.'

Sec. 7. R. S., c. 153, § 3, amended. That part of section 3 of chapter 153 of the Revised Statutes which relates to the salary of the judge of probate of Cumberland County, as amended by chapter 316 of the public laws of 1955, is further amended to read as follows:

'Cumberland, ~~\$6,500~~ \$7,500.'

Sec. 8. R. S., c. 153, § 22, amended. That part of section 22 of chapter 153 of the Revised Statutes which relates to the salary of the register of probate of Cumberland County, as amended by section 3 of chapter 411 of the public laws of 1955, is further amended to read as follows:

'Cumberland, ~~\$4,200~~ \$4,700.'
