STATE OF MAINE

IN THE YEAR OF OUR LORD NINETEEN HUNDRED FIFTY-NINE

AN ACT to Make Valid the Incorporation of School Administrative Districts Nos. 1, 2, 3, 4, 5 and 6.

Emergency preamble. Whereas, the towns comprising School Administrative Districts Nos. 1, 2, 3, 4, 5 and 6 have voted to join their respective school administrative districts and have been issued certificates of organization by the Maine School District Commission; and

Whereas, it is necessary to borrow money for the construction of safe and adequate school plants and to support an improved educational program; and

Whereas, there have been questions concerning the sufficiency of the proceedings in some of the town meetings of the respective districts which may impair the ability of such school administrative districts to borrow money; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now therefore,

Be it enacted by the People of the State of Maine, as follows:

Incorporation of School Administrative Districts Nos. 1, 2, 3, 4, 5 and 6 validated. The incorporation of School Administrative District No. 1 on the 21st day of May, 1958; School Administrative District No. 2 on the 17th day of July, 1958; School Administrative District No. 3 on the 15th day of August, 1958; School Administrative District No. 4 on the 29th day of August, 1958;

School Administrative District No. 5 on the 23rd day of September, 1958; and School Administrative District No. 6 on the 13th day of November, 1958, under the Revised Statutes of 1954, chapter 41, sections 111-A to 111-U, is hereby ratified, affirmed and made valid, and all acts and doings of their boards of school directors, in their capacity as school directors as shown by the records of School Administrative District No. 1, School Administrative District No. 2, School Administrative District No. 3, School Administrative District No. 4, School Administrative District No. 5, and School Administrative District No. 6, are hereby approved, ratified and declared to be valid and legal.

Emergency clause. In view of the emergency cited in the preamble, this act shall take effect when approved.
