STATE OF MAINE

IN THE YEAR OF OUR LORD NINETEEN HUNDRED
FIFTY-NINE

AN ACT Relating to Barber Apprentices, Barber Instructors and Barber Shop Licenses.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. R. S., c. 25, § 217, amended. The 3rd paragraph of section 217 of chapter 25 of the Revised Statutes, as repealed and replaced by chapter 48 of the public laws of 1955, is amended by adding after the first sentence, a new sentence, as follows:

'No person shall be eligible for a shop license unless such person, prior to making application for such license, has been licensed as a registered barber for at least 2 years, and had a minimum of 2 years' experience in a licensed barber shop.'

Sec. 2. R. S., c. 25, § 222, amended. The last sentence of the last paragraph of section 222 of chapter 25 of the Revised Statutes is repealed and the following sentences enacted in place thereof:

'No person, except physicians as specified above, shall be engaged to instruct in any practice of barbering as defined in section 214 unless said instructor has a certificate to practice barbering under sections 213 to 230, and had at least 5 years' experience in a registered barber shop prior to making application for an instructor's license. No applicant shall be issued an instructor's license until he has satisfactorily passed practical and written examinations conducted by the board. The fee for an instructor's license shall be \$7 in the first instance and \$5 for each yearly renewal. The license shall run from the first day of January in each year for one year and the fee shall be payable to the secretary

of the board. Such license shall not be renewed by the board if the person to be licensed thereunder for any reason shall have ceased to instruct barbering.'

Sec. 3. R. S., c. 25, § 223, amended. The 2nd paragraph of section 223 of chapter 25 of the Revised Statutes is amended by adding at the end, a new sentence, as follows:

'Any apprentice barber who shall qualify for examination and thereafter fails to pass 3 consecutive examinations shall cease barbering.'
