STATE OF MAINE HOUSE OF REPRESENTATIVES 99th LEGISLATURE

SENATE AMENDMENT "A" to H. P. 844, L. D. 1207, Bill, "An Act Revising Election Provisions in Charter of City of Lewiston."

Amend said Bill by striking out all of lines 4, 5, 6, 7 and 8 and inserting in place thereof the following:

"'Commencing in 1960, An an election shall be held on the 3rd-Monday in-February-ef-each-year first Monday in October every 2 years, at which the qualified voters of the city shall ballot for a mayor and the qualified voters of each ward shall ballot for a member of the board of aldermen, a warden, and a ward clerk.""

Further amend said Bill in the 7th line of section 2 by striking out the underlined word "November" and inserting in place thereof the underlined word 'October'

Further amend said Bill by striking out in the 6th line of section 4 the underlined words, punctuation and figures "November, A. D. 1959" and inserting in place thereof the following underlined words, punctuation and figures 'October, A. D. 1960'

Further amend said Bill by striking out in the 8th line of section 4 the underlined word "November" and inserting in place thereof the underlined word 'October'

Further amend said Bill by striking out in the last sentence of section 4 the underlined figure "1960" and inserting in place thereof the underlined figure '1961'

Further amend said Bill by striking out all of the last sentence of section 5 and inserting in place thereof the following:"The salary of the mayor shall be \$2,500 \$3,500 for-the-term per year, which shall be in full for the performance of his official duties."

Further amend said Bill by striking out in the 2nd sentence of that part designated "Sec. 9." of section 9 the figure "\$15" and inserting in place thereof the following: '\$15 \$20'

Further amend said Bill by striking out in the 2nd sentence of that part designated "Sec. 9." of section 9 the figure "\$500" and inserting in place thereof the following: '\$500 \$700'

Further amend said Bill in the last sentence of that part designated "Sec. 9." of section 9 by striking out the figure "\$5" and inserting in place thereof the following: '\$5 \$10'

Further amend said Bill by striking out in the 5th line of section 11 the underlined figure "1959" and inserting in place thereof the underlined figure '1961

Further amend said Bill by striking out all of that part designated "Sec. 15." of section 12 and inserting in place thereof the following:

A STATE OF

"'Sec. 15. Fiscal year. Commencing January 1, 1961 The the fiscal year of the city snall commence on the first day of April January and end on the 31st day of March December of each year."

Further amend said Bill by adding at the end the following Referendum Clause:

'Referendum; effective date; certificate to Secretary of State. This act shall take effect 90 days after adjournment of the Legislature, only for the purpose of permitting its submission to the legal voters of the City of Lewiston at the regular municipal election of the city in 1960.

The city clerk shall prepare the required ballots on which he shall reduce the subject matter of this act to the following question: "Shall the Act Revising Election Provisions in Charter of City of Lewiston, passed by the 99th Legislature, be accepted?" The voters shall indicate by a cross or check mark placed against the words "Yes" or "No" their opinion of the same.

This act shall take effect for all purposes hereof upon its acceptance by a majority vote of the legal voters voting at said election; provided that the total number of votes cast for and against the acceptance of this act at said election equals or exceeds 20% of the total vote for all candidates for Governor in said city at the next preceding gubernatorial election.

The result of such election shall be declared by the municipal officers of the City of Lewiston and due certificate filed by the city clerk with the Secretary of State.
