## CHAPTER XLVII.

AN ACT to set off part of the town of Baldwin, and annex the same to the town of Hiram.

Bounds of the part set off.

SECT. 1. *BE it enacted by the Senate and House of Representatives in Legislature assembled,* That all the lands within the town of Baldwin, in the county of Cumberland, which lie to the southwest of Hancock Brook and Pond, with the inhabitants thereon, be, and the same are hereby set off from said town, and are annexed to the town of Hiram, in the county of Oxford: *Provided however,* That the inhabitants on the aforesaid lands, and their estates, shall be holden to pay all taxes assessed on them prior to this act.

Boundary line between Cumberland and Oxford.

SECT. 2. *Be it further enacted,* That the aforesaid line between the towns of Baldwin and Hiram, shall in future be the county line between said counties of Cumberland and Oxford.

## CHAPTER XLVIII.

AN ACT to establish the boundaries of the town of Surry, as they existed previous to the third day of March, one thousand eight hundred and nine.

Part of Ellsworth property taken from Surry, set back to Surry.

*BE it enacted by the Senate and House of Representatives in Legislature assembled,* That, that part of the town of Ellsworth, which by An Act of the General Court of the Commonwealth of Massachusetts, passed on the third day of March, one thousand eight hundred and nine, was set off from the town of Surry and annexed to the said town of Ellsworth, be, and hereby is set back and annexed to the said town of Surry. And the inhabitants of the part thus annexed to the said town of Surry, shall hereafter be considered inhabitants of said town and shall there exercise and enjoy all civil rights and privileges, and be subject to all civil duties and requisitions in like manner as the other inhabitants of said town: *Provided however,* That said inhabitants of the part of the town of Ellsworth, thus annexed to the town of Surry, shall be respectively holden to pay their due proportions of all debts due from, and of all monies granted prior to the passing of this act, by said town of Ellsworth.

Inhabitants to pay their part of debts due, and monies granted prior to the passing of the act.
