CHAPTER LXXIII.

AN ACT to change the names of certain persons,

BE it enacted by the Senate and House of Representatives in Legislature assembled, That Francis Arguier, of Portland, in the county of Cumberland, mariner, shall be allowed to take the name of Francis A. Newton; Charles Fisher Bruce, son of Charles Bruce, of Waldoborough, in the county of Lincoln, shall be allowed to take the name of Charles Hale; John Dunning, third, of Brunswick, in the county of Cumberland, shall be allowed to take the name of John Andrew Dunning; Rhoda Davis, of Gorham, in said county, single woman, shall be allowed to take the name of Rhoda Morris Davis; Levi Kendall, of Lyman, in the county of York, shall be allowed to take the name of Ralph Kendall; John Littlefield, son of Jeremiah Littlefield, late of Hallowell, in the county of Kennebec, deceased, shall be allowed to take the name of John Littlefield Hodsdon; Levi Merrill, third, of Greene, in said county, shall be allowed to take the name of Levi Waldo Merrill; John Megguier, of Portland, in the county of Cumberland, shall be allowed to take the name of John Louville Megguier; Joseph Prince, second, of Portland, in said county, shall be allowed to take the name of Joseph Brackett Prince; Simon Simpson, of York, in the county of York, shall be allowed to take the name of Joseph Simon Simpson; John Scammans, third, of Saco, in said county, shall be allowed to take the name of Frederick Scammans; Washington Stanley, of Wintthrop, in the county of Kennebec, shall be allowed to take the name of George Washington Stanley; Lynde Valentine, of Bangor, in the county of Penobscot, shall be allowed to take the name of Samuel L. Valentine; Samuel Ward, third, of China, in the county of Kennebec, shall be allowed to take the name of Samuel Clark Ward. And the said persons from the time of the passing of this act, shall be called and known by the names which, by this act they are severally allowed to take as aforesaid, and the same shall be considered as their only proper and legal names, to all intents and purposes.
