Committee on the part of this State, to meet a Committee to be appointed by the Legislature of the Commonwealth of Massachusetts, which Committee on the part of this State, shall have full power and authority to negotiate, settle, adjust and determine with the Committee of the said Commonwealth of Massachusetts, having similar and competent powers, for that purpose, and on that behalf, all the stipulations, terms and conditions of a contract, by which the right, title and interest of the said Commonwealth, in the lands in this State, which have become the property of said Commonwealth, by the provisions of the Act, entitled "An Act relative to the separation of the District of Maine from Massachusetts proper, and forming the same into a separate and independent State," may be transferred to this State; which contract, when made as aforesaid, shall by the said Committee be submitted, as soon as may be, to the Legislatures of this State and of Massachusetts, respectively, for their approbation and ratification.

*Resolved*, That said Committee on the part of this State, whenever such contract shall have been made and ratified as aforesaid, be, and they hereby are authorized and empowered to execute all covenants, conveyances, promises, releases or other instruments, and to do and perform every other act and thing, which shall be necessary to carry into full and complete effect, the stipulations, terms and conditions, which may be specified and contained in such contract; and to receive deeds executed by the authority of said Commonwealth, which shall convey to this State, the right, title and interest of said Commonwealth in and to the lands aforesaid.

In the House of Representatives, January 29th, 1821, read and passed; and Nicholas Emery, Esq. was elected on the part of the House of Representatives, a member of said Committee.

In Senate, January 29, 1821. Read and passed, and the Hon. Daniel Rose, Esq. was elected on the part of the Senate, a member of said Committee.

## CHAPTER VI.

Resolve authorizing Elijah Fairbanks, Administrator of Joseph Rice, deceased, to convey certain land. *February 5, 1821.*

On the petition of Samuel Floyd and Anna Floyd, his wife:

*Resolved*, That, for the reasons set forth in said Petition, Elijah Fairbanks, Administrator of the goods and estate of Joseph Rice, deceased, be, and is hereby authorized, in his said capacity, to convey by deed the following described tract of land lying in Winthrop, in the county of Kennebec, being a part of lot numbered seven, and bounded as follows: viz. Beginning at a stake and stones on the easterly side of the road leading through said lot, numbered seven,

about twenty five rods from the north line of said lot; thence east south east to the great Pond, so called; thence southerly on said Pond to Isaac Shaw's land; thence west north west on said Shaw's land to said road; thence northerly on the easterly side of said road to the bounds first mentioned, to Anna Packard, to hold for and during her natural life. And the reversion of the same to convey by deed as aforesaid, to the said Anna Floyd, and her heirs and assigns.

## CHAPTER VII.

Resolve on the petition of Mary Merrill, Administratrix, for leave to convey real estate. *February 5, 1821.*

*Resolved,* That Mary Merrill, of Bristol, in the county of Lincoln, widow, Administratrix of the goods and estate of Robert Merrill, late of said Bristol, deceased, be, and she hereby is authorized and empowered to convey by a good and sufficient deed of release and quit claim, to Mark Feltis, of Bristol, aforesaid, tailor, a certain lot of land situated in said Bristol, bounded and described as follows: viz. beginning at a hemlock tree marked on four sides on David Arskine, senior's, north line, on the easterly side of Pemaquid fresh Pond, so called; thence running east south east, two hundred and twenty-five rods, to an oak tree marked on four sides; thence north-east twenty one rods, to a stake and stones; thence west north west, two hundred and ten rods to a hemlock tree marked on four sides at the shore of said Pond; thence southerly by the shore of said Pond to the first mentioned bound, containing twenty nine acres more or less. And the deed of said Mary, made in conformity hereto, shall be good and valid, to vest the fee of said land in said Mark Feltis, to the same effect as though a deed had been made of the premises to said Feltis, by said Robert Merrill in his life time.

## CHAPTER VIII.

Resolve granting a further compensation to the Clerks of the Senate, and of the House of Representatives, and their respective assistants for services. *Feb. 5, 1821.*

*Resolved,* That there be paid out of the Treasury of this State, to Ebenezer Herrick, Esq. Secretary of the Senate, thirty dollars; and to James L. Child, Esq. Clerk of the House of Representatives, thirty dollars, as further compensation to the said Secretary and Clerk, and their assistants, respectively, for services in making up their Journals, and arranging their papers of the last session.
