CHAPTER IX.

Resolve granting a sum of money to Decun Socobason, Agent for the Passamaquoddy Indians, to defray certain expenses. *February 8, 1821.*

ON the petition of Decun Socobason, Agent for the Passamaquoddy Tribe of Indians, praying for relief:

Resolved, For reasons set forth in said Petition, That there be allowed and paid out of the Treasury of this State, to Decun Socobason, one hundred and thirty dollars for the purpose of defraying the expenses of himself and his colleagues in travelling from Passamaquoddy to Portland, and to enable them to return. And the Governor is hereby requested to draw his warrant on the Treasurer for the same: *Provided,* The said Decun Socobason, as Agent for said Tribe of Indians, shall give the Treasurer an obligation to repay the same sum to him, or his successor in office, out of the proceeds of the first sales of timber from the lands of said Indians.

CHAPTER X.

Resolves ratifying and confirming a Treaty with the Penobscot Indians. *Feb. 9, 1821.*

Resolved, That the Treaty concluded with the Penobscot Tribe of Indians, on the seventeenth day of August, in the year of our Lord, one thousand eight hundred and twenty, by Lothrop Lewis, Esq. Agent in behalf of the State of Maine, commissioned by the Governor for that purpose, pursuant to a Resolve of the Legislature of this State, passed on the twentieth day of June, in the year of our Lord, one thousand eight hundred and twenty, be, and the same is, by this State, ratified and confirmed, according to the true intent and meaning thereof.

Resolved, That a duplicate of the original release of the Penobscot Tribe of Indians to the Commonwealth of Massachusetts, together with a true and attested copy of said Treaty, be transmitted by the Governor of this State, to the Commissioners appointed agreeably to the Act of Separation, for the purpose of carrying into effect the provisions of the said Act.

CHAPTER XI.

Resolve making valid certain doings of the First Parish in the town of Wiscasset. *February 10, 1821.*

ON the petition of the First Parish in the town of Wiscasset, in the County of Lincoln, stating that doubts had arisen respecting the
