Moses, and James, of the real estate aforesaid, by them respectively held in severalty; and to receive a deed of release from them, the said Morris, Moses and James, of all their right and title to the real estate aforesaid, for the use and benefit of the heirs and minor children of the said intestate: Therefore,

Resolved, That said Jeremiah Goodwin, in said capacity of administrator on the estate of the said Daniel Goodwin, Esq. deceased, intestate, be, and he hereby is authorized and empowered to make and execute, and also receive, good and sufficient deeds of conveyance of the lands aforesaid, according to the request contained in the petition aforesaid, which deeds when so executed shall be good and sufficient in law.

CHAPTER XXVIII.

Resolve laying a tax on the several Counties. *March 12, 1821.*

WHEREAS the Treasurers of the following Counties have laid their accounts before the Legislature, which accounts have been examined and allowed; and whereas the Clerks of the Courts of Sessions for said Counties, have exhibited estimates made by said Courts of the necessary charges which may arise within the said several counties, for the year ensuing, and of the sums necessary to discharge the debts of said Counties:

Resolved, That the sums annexed to the several Counties, contained in the following Schedule, be, and the same are hereby granted as a tax for each county respectively, to be apportioned, assessed, paid, collected and applied for the purposes aforesaid, according to law.

CHAPTER XXIX.

Resolve prescribing the forms of Returns of Votes for Governor and Senators, and of Certificates of Elections of Representatives. *March 13, 1821.*

Resolved, That, from and after the passing of this Resolve, the returns of votes for Governor, shall be in the following form, viz :—

At a legal Meeting of the Inhabitants of the [town or plantation as the case may be] of _____, in the County of _____, qualified by the Constitution to vote for Governor, holden on the second Monday of September, being the _____ day of said month, in the year of our Lord, one thousand eight hundred and twenty _____.

The said Inhabitants gave in their votes for a Governor, and the same were received, sorted, counted and declared in open [town or plantation as the case may be] meeting, by the [Selectmen or Assessors as the case may be] who presided; and in presence of the [town or plantation as the case may be] Clerk, who formed a list of the persons voted for, and made a record thereof as follows, to wit:

CHAPTER XXX.

Resolve authorizing the Treasurer of the State to obtain a loan of thirty thousand dollars. *March 13, 1821.*

Resolved, That the Treasurer be, and he hereby is authorized to obtain, on the faith of the State, a loan of thirty thousand dollars, at an annual interest not exceeding six per centum, or such part of said sum as the exigencies of the State may require, previous to the first session of the next Legislature.

CHAPTER XXXI.

Resolve compensating Daniel Rose and Nicholas Emery, Esquires, for certain services. *March 13, 1821.*

Resolved, That there be allowed and paid out of the Treasury of this State, to Daniel Rose and Nicholas Emery, Esquires, in addition to their travel and pay as members of the Legislature, for their services and expenses while on Committee for the purchase of lands belonging to the Commonwealth of Massachusetts, within this State, seventy-four dollars each; and that the Governor, with advice of Council, be authorized and requested to draw his warrant on the Treasury for the same.
