CHAPTER XXXII.

Resolve confirming the doings of the Town of Avon. *March 13, 1821.*

ON the Petition of the Selectmen of the town of Avon, setting forth several irregularities and omissions in the Records of said town :

Resolved, That for the reasons set forth in said petition, the Records aforesaid are hereby confirmed and made valid in law, to all intents and purposes ; the omissions of the Town Clerk to record the Selectmen's warrants for calling town meetings ; of not recording the Constable's returns ; of not attesting the Records ; and it not being certified in many cases, that town officers were sworn, notwithstanding : *Provided*, That nothing in this resolution shall be construed to effect any suit at law now pending.

CHAPTER XXXIII.

Resolve on the Petition of Moses Manson, making valid his marriage. *March 13, 1821.*

ON the Petition of Moses Manson, representing that he having been united in matrimony to Hannah R. Bicknell, his present wife, and having a lawful right so to do ; their intentions accordingly having been legally published by the Town Clerk of Palmyra, county of Somerset ; and that he was married by a Baptist Minister, ordained according to the usage of the Society, as Minister at large ; and that doubts have been expressed respecting the validity of the said marriage :

Resolved, That the marriage aforesaid, of the said Moses Manson with said Hannah R. Bicknell, solemnized in manner aforesaid, be, and the same is hereby declared to be legal and valid to all intents and purposes of marriages ; and the children of the said marriage are hereby declared to be legitimate, as if the said marriage had been solemnized by a person legally empowered for such purpose.

CHAPTER XXXIV.

Resolve authorizing the Secretary of State to purchase Stationary. *March 15, 1821.*

Resolved, That the Secretary of State be required to purchase the necessary Stationary for the Offices of Adjutant General, Quarter-Master General, Secretary of State, Treasurer of State, and also for the Executive and Legislative Departments of Government ; and that no account for Stationary be allowed without his certificate, that the same is equitable and just.
