## CHAPTER LVI.

Resolve authorizing the Adjutant General to procure the printing of the Militia Law of this State. *March 19, 1821.*

*Resolved,* That the Adjutant General be authorized and directed to procure the printing of six hundred copies of the Militia Law of this State, to be distributed among the officers of the Militia, as the Commander in Chief may direct.

## CHAPTER LVII.

Resolve authorizing the Governor to apply for, and receive certain Arms and Military Stores from Massachusetts. *March 19, 1821.*

*Resolved,* That, if the Commonwealth of Massachusetts shall ratify the agreement concluded between the Committees of the Legislatures of said Commonwealth, and of this State, on the fourteenth day of February last, the Governor of this State shall be authorized to take measures to obtain the share of Ordnance, Arms, Military Stores and Munitions of War, belonging to this State, in the possession of the Commonwealth of Massachusetts; and to cause the same or any part of the same, to be removed to this State, and to provide for the safe keeping thereof.

## CHAPTER LVIII.

Resolve making valid the doings of Andrew M'Clary Chapman. *March 19, 1821.*

WHEREAS it has been represented to this Legislature that certain doings of Andrew M'Clary Chapman, as a Justice of the Peace for the County of York, are informal and illegal, in that, on the eighth day of February last, he took the acknowledgment of two deeds, viz: one from Samuel Parker, and Mary his wife to John Trueworgy; the other from John Trueworgy to Mary Parker, conveying certain real estate in said deeds mentioned; also administered oaths to certain appraisers on the estate of Nathaniel Fernald, late of Parsonsfield, deceased; and also issued a warrant in behalf of the State, upon the complaint of Paul Burnham against Jonathan Piper, for assault and battery, by force of which the said Piper was brought before him on the ninth day of February last, and sentenced to pay a fine, to the use of the State, of one dollar, and costs of prosecution taxed at seven dollars and sixty one cents: Therefore,

*Resolved,* That the doings of the said Andrew M'Clary Chapman, as aforesaid, be, and the same are hereby made valid in law, to all intents and purposes as if he had been qualified as a Justice of the Peace for said county, according to law.
