Resolved, That there be allowed and paid out of the public Treasury to the several persons mentioned in the preceding Roll, the sums set against such persons name respectively, amounting in the whole to three thousand four hundred and eighty six dollars and fifty three cents, the same being in full of the accounts and demands to which they refer: And the Governor, with advice of Council, is hereby authorized to draw his warrant on the Treasury for the same.

CHAPTER LX.

Resolve directing the Treasurer to pay the expenses of a Court Martial to Samuel E. Smith. *March 21, 1821.*

Resolved, That the sum of two hundred eighty eight dollars and twenty two cents, set to Samuel Page, Brigade Major, in the Rolls of the Committee on accounts, for the expense of a Court Martial, holden at Nobleborough, on the eleventh day of September, A. D. 1820, be paid by the Treasurer to Samuel E. Smith, Judge Advocate of the fourth Division of the Militia, to be paid by said Judge Advocate, on demand, to the persons severally entitled to receive the same.
