House of Representatives, two dollars for each and every day's attendance during the present political year, and the sum of two dollars for every ten miles travel from their respective places of abode, at every session thereof; and that there be paid to the President of the Senate, and to the Speaker of the House of Representatives, two dollars, each, for each and every day's attendance, in addition to their pay as members. Also, that there be allowed and paid unto the Secretary of the Senate, and to the Clerk of the House of Representatives, the sum of three dollars and fifty cents each; and to the assistant Secretary of the Senate, and the assistant Clerk of the House of Representatives, three dollars; and to John Merrill, for his services as Messenger and door-keeper to the Senate two dollars; and to Isaiah Ingalls, for his services to the Senate, one dollar and fifty cents; and to Moses Davis, for his services as Messenger, door-keeper and page, four dollars, for each and every day they shall respectively be employed while the Legislature shall be in session.

## CHAPTER XXVI.

Resolve authorizing the Governor to appoint one or more Agents for the preservation of Timber on the public lands, and for other purposes.

*Resolved,* That the Governor, by and with the advice of Council, be, and he is hereby authorized and empowered to appoint one or more Agents, whose duty it shall be to perform all such acts and duties relating to the care and preservation of the timber and grass on the public lands, or the sale of any part thereof, as shall from time to time be prescribed by the Governor of this State; and said Agent or Agents, shall receive such reasonable compensation for their services, out of the proceeds of any timber or grass by him or them sold under the authority aforesaid, as the Legislature shall direct; and said Agent or Agents shall annually render to the Legislature a true and perfect account of all grass or timber by him or them sold the pre-

ceding year: And that the Resolve passed June twenty-sixth, one thousand eight hundred and twenty, authorizing the appointment of a Surveyor and land Agents, be, and the same is hereby repealed.

## CHAPTER XXVII.

Resolve authorizing John Gray to convey by deed a lot of land in the town of Freeport.

*Resolved*, for reasons set forth in the petition of John and William Soule, That John Gray, of North-Yarmouth, be, and he is hereby authorized and empowered to make and deliver to the said John Soule, a good and sufficient deed of five sixths of one half of the one hundred acre lot Number twenty nine, on Range B, in the town of Freeport, formerly the property of John and Joshua Gray, and Mahetabel Cutter.
