Resolved, That the doings of said Nancy Bucknam, in the sale of the estate and the execution of the deed aforesaid, notwithstanding said oath was not taken, and any informality which may be in said deed, be, and the same are hereby made valid in law to all intents and purposes.

CHAPTER XXXIII.

Resolve in favor of certain Clergymen.

Resolved, That there be paid out of the Treasury of this State to the Rev. Elijah Kellogg, Chaplain of the Senate, twenty five dollars; and to Elijah Kellogg, Joshua Taylor, Edward Payson, Ichabod Nichols, Thomas B. Ripley, Petrus S. Ten Broeck, Russell Streeter and David Kilbourn, Chaplains of the House of Representatives, five dollars each, in full for their services during the present Session of the Legislature; and that the Governor, with advice of Council, be requested to draw his warrant on the Treasury for the same.

CHAPTER XXXIV.

Resolve authorizing William G. Warren and Remember Goodwin to convey certain real estate.

On the petition of Timothy White, of Hallowell, in the County of Kennebec, praying that the administrators upon the goods and estate of James Goodwin, late of said Hallowell, yeoman, deceased, may be authorized to convey to said White certain real estate :

Resolved, for reasons set forth in the petition aforesaid, That William G. Warren and Remember Goodwin, Administrators upon the goods and estate of said James Goodwin, deceased, be, and they are hereby authorized and empowered, by deed under their hands and seals, to convey

to said White all the real estate which said White did convey to said James Goodwin, as mentioned and described in the petition aforesaid, viz. All the real estate, and all the right, title and interest in or to real estate which said White did convey to said James Goodwin, by his, the said White's deed, dated the thirty first day of August, in the year of our Lord one thousand eight hundred and sixteen, and recorded in the Registry of Deeds for the County of Kennebec, Book twenty five, page three hundred and forty three. Also, all the right, title and interest which said White did, by his deed, dated the twentieth day of September, in the year of our Lord one thousand eight hundred and sixteen, convey to said James Goodwin, in the following described tract of land; bounded on the south side, by land which was, on said twentieth day of September, in the possession of, or owned by Captain Benjamin Prescott; on the west side, by the rear of the fifth mile or fort lands, (so called,) lying in Augusta, on the east side of the River; on the north side, by land which, on said twentieth day of September, was owned by said James Goodwin and others; and bounded on the east side, by the east line of the town of Augusta, containing two hundred acres more or less; and is the tract of land purchased by said White and others in the year one thousand eight hundred and fifteen, of John Searles; *Provided, however*, that said White shall first pay to the said Administrators all the debts due from him the said White to the estate of said James Goodwin, and shall also remove all the liabilities which said James, was, at the time of his death, subject to for said White; and *provided also*, that the guardian, or guardians appointed, or to be appointed, to the infant children of said James, shall in writing consent to the making of said conveyance. And the deed or deeds of conveyance, to be made by said William and Remember to said White, pursuant to the provisions of this Resolve, shall vest in said White, his heirs and assigns, in fee, all the right, title and interest, which said White had in or to said real estate before the conveyances made by him, as aforesaid, to said James Goodwin, deceased.
