SECT. 2. Be it further enacted, That all the inhabitants of the town of North Salem, who, prior to the Taxes assessed by Phillips and passage of this act, were inhabitants of the towns of Phillips and Freeman, shall be severally holden to pay all taxes now duly assessed upon them in the several towns to which they belong, in the same manner they would have been, had not this act passed; and all officers shall have the same right to enforce the collection of said taxes as they heretofore have had.

Sect. 3. Be it further enacted, That in all State State taxes how taxes which may be granted by the Legislature, previous to a new valuation, one sixth part of the taxes which would have been set to the said towns of Phillips and Freeman, according to the last valuation, shall be set to the said town of North Salem.

First meeting.

Sect. 4. Be it further enacted, That Samuel Blake, Esquire, of Phillips, in the county of Somerset, be, and he hereby is authorised to call the first meeting of said inhabitants, by issuing his warrant to an inhabitant thereof, directing him to notify said inhabitants to meet at such time and place as he shall appoint, to choose such officers as other towns are empowered to choose at their annual meetings.

### CHAPTER CLIII.

AN ACT to cede to the United States of America the jurisdiction of, land on Monhegan Island.

Sect. 1. BE it enacted by the Senate and House of Representatives, in Legislature assembled, That there Boundaries of be, and hereby is ceded to the United States of Amer-lot ceded. ica, the jurisdiction of a certain lot of land on Lookout-Hill, on the Island of Monhegan, in the State of Maine, bounded as follows: beginning at a stake standing east by south one rod and sixteen links from the easterly corner of the burying place; thence running east by south fifteen rods; thence southeast by south eight rods; thence south southeast six rods; thence south by west seven rods; thence west, seventeen degrees north twenty-five rods and sixteen links; thence northeasterly fourteen rods to the first bounds, containing two acres and thirty-one rods, for For site of hight-house. the purpose of erecting a light-house and dwelling house; being the same land that has been purchased for the said United States of Josiah Starling by deed.

SECT. 2. Be it further enacted, That this State Jurisdiction shall have concurrent jurisdiction with the United United States. States in and over the said two acres and thirty-one rods of land, and the houses when erected, so far as that all civil and criminal processes, issued under the

authority of this State, or any officer thereof, may be executed on any part of the said granted premises, or in any building that may be erected thereon, in the same way and manner as if the jurisdiction had not

been ceded as aforesaid.
