CHAPTER CCLX.

AN ACT to annex a part of Swanville to Waldo Plantation.

SECT. 1. *BE it enacted by the Senate and House of Representatives, in Legislature assembled, That, from and after the passing of this act, so much of the town of Swanville as lies within the following boundaries, to wit : beginning at a hemlock tree in the southwest corner of said Swanville; thence running on the line dividing said Swanville from Waldo, north twenty-four degrees west three miles and seventy-eight rods to a yellow birch tree in the northwest corner of said Swanville; thence north fifty-six degrees east two miles and two hundred sixty-eight rods to a stake in the most northerly corner of lot number eighty-five; thence south thirty-four degrees east one mile 159½ rods to a maple tree at the most southerly corner of lot number 98; thence south, 24 degrees west one mile and 176 rods to a stake in the northeast corner of lot number 50; thence south 263 rods to a stake in the corner of lot number 4; thence south 6 degrees east 222½ rods to a stake in the line of Belfast, in the southeast corner of lot number 45 in Swanville aforesaid; thence south 69 degrees west one mile and 153 rods by the line of Belfast, to the place began at, together with the inhabitants thereon, be, and they hereby are set off from the town of Swanville, and annexed to the Plantation of Waldo, in the County of Hancock, and shall there exercise and enjoy all the rights and privileges of said Plantation of Waldo, and shall be subject to the same duties and requisitions as the other inhabitants of said Plantation : Provided, however, That the inhabitants of said Swanville, hereby set off to said Waldo, shall be held to pay all assessments upon them, remaining unpaid to said Swanville prior to the passing of this act; and the inhabitants set off as aforesaid, shall be entitled to the benefit of the money raised for the support of schools in the tract so set off, which has been assessed and unexpended before the passing of this act.*
