CHAPTER CCCIII.

AN ACT to cede to the United States of America, the jurisdiction of certain lands.

SECT. 1. Be it enacted by the Senate and House of Representatives, in Legislature assembled, That there be, and hereby is, ceded to the United States of America, the jurisdiction of a certain tract of land Tract ceded, at Owlshead in situated at Owl's Head (so called) in the town of Thomaston. Thomaston, in the County of Lincoln, and State of Maine, containing seventeen acres and one quarter of an acre, bounded as follows, viz. Beginning at the northwest corner of Josiah W. Dodge's land, at said Uwl's Head, thence running south, sixteen degrees west, thirty five rods, to the road on the bank; thence westerly by the road, one rod; thence Boundaries. north, sixteen degrees east, thirty eight rods ; thence south, seventy four degrees east, one rod ; thence north, sixteen degrees east, seventeen rods; thence north, forty five degrees east, eighty four rods, to the shore; thence by the shore, easterly and southerly, to the north east corner of said Dodge's land; thence north, fifty nine degrees west, twenty one rods, to the first mentioned bounds, for the purpose of erecting a Light House and Dwelling House thereon.

SECT. 2. Be it further enacted, That there be, and hereby is, ceded to the United States of America, the jurisdiction of a certain tract of land, situat-Tract ceded ed in Biddeford, in the County of York, bounded as follows, viz. Begiuning at a point, fifty nine rods, bearing south seventy eight degrees east, from a rock with an iron bolt, on Jordan's point (so called) Boundaries. at a stake ; thence running south, sixty seven degrees east, twenty two rods ; thence north, eighty eight degrees east, three hundred and four rods, to the west of Sharp's Rocks (so called ;) thence north, sixteen degrees west, one hundred and eighteen rods, to Ram Island north west ledge ; thence south, sixty nine degrees west, three hundred and eleven rods, to the stake aforesaid, (said tract of land being mostly covered with water,) for the purpose of building a Pier, and placing buoys at the mouth of Saco River.

SECT. 3. Be it further enacted, That there be,

and hereby is, ceded to the United States of Ameri-Tract ceded in ca, the jurisdiction of a certain tract of land, containing about eighteen acres of Beach, situated at the mouth of Wells Harbour, in the county of York, bounded as follows: Beginning eighteen rods south east by south from the Wharf of Nahum Morrell; thence running south south east, ninety two rods, to the Sea; thence running easterly by the Sea, or low water mark, thirty two rods ; thence running north north west, to the Sea wall, or sand hillocks; thence by the said Sea wall, or sand hillocks, to the bounds first mentioned, for the purpose of erecting a Pier at the mouth of Wells Harbour.

Be it further enacted, That this State Sect. 4. shall have concurrent jurisdiction with the United Concurrent in States, in and over each of the aforesaid tracts, hererisdiction re- in before granted, so far, as that all civil and criminal processes, issued under the authority of this State, or any officer thereof, may be executed on each or any part of the said tracts of land, or in w any buildings that may be erected on them, or any of them, in the same way and manner as if the jurisdiction had not been ceded as aforesaid.

SECT. 5. Be it further enacted, That the Act, entitled "An Act to cede to the United States of Arepealed for merica, the jurisdiction of certain lands," passed February fifth, [seventh] in the year of ourLord one thousand eight hundred and twenty five, be, and the same is hereby repealed, the tracts of land therein mentioned, being incorrectly described.
