EIGHTH LEGISLATURE

STATE OF MAINE,

PASSED AT THE SESSION

WHICH COMMENCED ON THE SECOND DAY OF JANUARY, AND ENDED
ON THE TWENTY-SIXTH DAY OF FEBRUARY, ONE THOUSAND
EIGHT HUNDRED AND TWENTY-EIGHT.

CHAPTER VI.

An Additional Resolve for opening and clearing a road from the south line of Township number two, Old Indian Purchase, on the East side of Penobscot River, to the Metanawcook Stream.

Resolved, That the Governor and Council be authorized to examine and settle the account of Joshua Carpenter, Esq. the Agent appointed to carry into effect the Resolve to which this is additional, and to certify to the Land Agent the sums respectively due to said Carpenter and to the persons by him employed in making the road in conformity to the powers granted by the original Resolve. And said Land Agent is authorized to allow to said persons respectively, the several sums that may be so certified to be due them, out of any demands now due from them respectively for land sold in the townships through which said road is made. And if there be no demands, or no sufficient demands against the person or persons thus entitled to compensation for making said road, the Land Agent may pay such person or persons the balance, or the full sum (as the case may be) which may be due him or them, by any debts due to the State for land sold within the townships through which said road is made.

Resolved, That the Governor, with advice of Council, be authorized to extend the time for performance of such of the contracts for making said road, as he may think for the interest of the parties, and not prejudicial to the State: *Provided*, Such extended time be not longer than until the first day of September next.

CHAPTER VII.

Resolve in favor of Josiah Morrill.

Resolved, That there be allowed and paid to Josiah Morrill, twenty-five dollars on account of an injury sustained while on Militia duty.

CHAPTER VIII.

Resolve in favor of the town of Steuben.

Resolved, That the State Treasurer be, and he hereby is, authorized to pay the town of Steuben, twenty-six dollars; said town having been overtaxed that sum in the State Tax for the year one thousand eight hundred and twenty-six.

Be it further Resolved, That the Court of Sessions for the county of Washington be, and they hereby are, authorized to direct the County Treasurer of said County, to pay to the town of Steuben, by reason of said town's having been over-taxed in the county tax for the year one thousand eight hundred and twenty six, as to said Court may appear to be just and reasonable.

CHAPTER IX.

Resolve relating to the State Arsenal.

Resolved, That the Governor and Council be, and they hereby are authorized to cause to be sunk a Well of water, at or near the State Arsenal ; and also to cause to be erected a suitable fence around said Arsenal. And the sum of five hundred dollars is hereby appropriated to defray the expenses of the objects aforesaid.

CHAPTER X.

Resolve in favor of Timothy Hall, Junior.

Resolved, That the sum of four dollars per month, be allowed and paid to Timothy Hall, Jun., on account of injury sustained while on Militia Service, to commence on the first day of January, one thousand eight hundred and twenty eight, and to continue for the term of three years.

CHAPTER XI.

Resolve in favor of Thompson Pond Plantation.

Resolved, That the Court of Sessions for the County of Cumberland be, and they are hereby authorized to order that there be paid from the County Treasury, to Thompson Pond Plantation, such portion, not exceeding one fourth part, of the County Tax, as was assessed upon said Plantation from the year one thousand eight hundred and twenty one to the year one thousand eight hundred and twenty seven, inclusive, as to said Court may appear to be just and right.
