### CALL AND A SEAL CHAPTER CCCCXII. STORE DATA

AN ACT to authorize the Court of Sessions in the County of Lincoln, to lay out a Road across Friendship River.

BE it enacted by the Senate and House of Representatives, in Legislature assembled, That Representatives, in Legislature assemute, find the Court of Sessions for the County of Lincoln authorized to by be, and they hereby are authorized to cause a Friendship iver, the north above Friendship Road to be located and laid out from the north mill end of a road in the town of Friendship, across said River, immediately above a Tide Mill, called Friendship Mill, to the south end of a road in the town of Cushing, leading to said Mills.

Approved by the Governor, February 5th, 1829.

lations, not repugnant to the laws of the State, for perfecting themselves in military knowledge and discipline, in which they may determine what number of company trainings they will have in each year; and may establish penalties and forfeitures to enforce the observance thereof, to be recovered by action of debt in any Court of competent jurisdiction, for assessing and collecting funds, and for any other purposes necessary for the good order and government of such companies; which by-laws and regulations shall be binding on such of the members thereof as subscribe their names to the same.
