SECT. 6. Be it further enacted, That the first meeting of said corporation may be called at First meeting. such time and place, as may be determined upon by a majority of the persons herein named, by publishing notice thereof in the newspaper, printed in Gardiner, ten days at least, prior thereto.

SECT. 7. Be it further enacted, That the Powers herein Legislature may enlarge, restrain, or annul the revision by the Lepowers granted by this Act.

AN ACT for the preservation of the Kennebec Bridge.

Approved February 21, 1829.

SECT. 1. SECT. 2. Be it further enacted, That if any person or persons (after being notified that he or they must not ride or drive, a horse or horses, upon or over said bridge faster than a walk,) shall willingly ride or drive any horse or horses, over or upon said bridge, in a pace faster than a walk, he or they, so offending, shall forfeit and pay for each offence, the sum of three dollars, to be recovered by the Treasurer of the Proprietors of said bridge, to the use of said proprietors, in any Court of competent jurisdiction. #### AN ACT for the preservation of the Southwest Bend Bridge.

#### Approved February 21, 1829.

Be it enacted by the Senate and Sест. 1. House of Representatives, in Legislature assembled, That from and after the first day of April driven over the next, it shall not be lawful for any person or persons to ride or drive any horse or horses, over or upon the Southwest Bend Bridge, faster than upon a walk, provided, the proprietors of said bridge shall keep constantly exposed to view, at each end of said bridge, a board upon which notice of this regulation shall be conspicuously painted.

SECT. 2. Be it further enacted, That if any person or persons, after being notified that he or they must not ride or drive a horse or horses, upon or over said bridge faster than a walk, shall willingly ride or drive, any horse or horses over or Penalty for viola-upon said bridge in a pace faster than a walk, he or they so offending, shall forfeit and pay for each offence the sum of three dollars, to be recovered
