# RESOLVES.

## JANUARY SESSION, 1829.

### CHAP. 1.

An additional Resolve for opening and clearing a road from the south line of township number two, Old Indian Purchase, on the east side of Penobscot River, to the Mattanawcook Stream ; and for the relief of certain persons.

Approved January 22, 1829.

RESOLVED, That the Land Agent be authorized to allow to those persons, in whose favor the Governor, or Governor and Council have granted certificates, in compliance with the Resolves to which this is additional, the respective sums so certified to be due them, out of any demands now due from them respectively to the State, for any land sold them by the State : *Provided*, That if there be demands now due from such person or persons thus entitled to compensation, for land sold him or them in the townships through which the said road is made, such demands are to be first paid out of the amount so certified to be due.

### CHAP. 2.

Resolve authorizing Julia B. Jones to convey real estate.

Approved January 28, 1829.

ON the petition of William Fitch, and Sally Fitch, representing that one Abel Jones, late of Bristol, in the State of Rhode-Island, deceased, in his life time made, executed, and delivered to one Joseph Fitch, then in full life, a bond wherein it was agreed, that said Abel Jones, should convey to said Joseph Fitch in fee, the lots of land situated in Sebago, in the county of Cumberland, numbered six and seven, in the third range east, on

certain conditions specified in said bond, and that said conditions have been performed. That said Abel Jones, deceased, without having made said conveyance. And that said Joseph Fitch, deceased, leaving Richard Fitch, William Fitch, Sibyl Potter, Betsey Farnsworth, Zachariah Fitch, John Fitch, Sally Farnsworth, Abigail Fitch, Luther Fitch, and the children of Rebecca Whitney, his legal heirs, and praying that said Julia B. Jones, John Wardwell and John How, or either of them, may be authorized to make to the said heirs of said Joseph a good and valid conveyance of said two lots of land.

**RESOLVED**, For the reasons set forth in said petition, that said Julia B. Jones, be authorized and empowered to convey by good and sufficient deed, to the said heirs of said Joseph Fitch, the said two lots of land in fee, in the proportion of one tenth part to each, excepting the children of said Rebecca Whitney shall take only one tenth part.

### CHAP. 3.

Resolve in favor of Thomas H. Norcross.

Approved January 28, 1829.

**RESOLVED**, That there be paid out of the Treasury of the State, to Thomas H. Norcross, ten dollars, as a compensation for a wound received on the nineteenth of September, eighteen hundred and twenty eight, while doing military duty.

### CHAP. 4.

Resolve providing for the promulgation of the Laws of the State.

Approved January 28, 1829.

**RESOLVED**, That the Portland Advertiser and Gazette of Maine, a newspaper printed in Portland, be, and the same hereby is declared to be the public newspaper in this State, in which shall be published the Laws and Resolves of a public nature, and also all advertisements, notices or orders, required by law to be published in the public newspaper of the printer to the State.

**BE IT FURTHER RESOLVED**, That all Resolves or parts of Resolves, inconsistent herewith, be, and the same are hereby repealed.
