CHAP. 5.

Resolve respecting the dividing line between Hollis and Waterborough.

Approved January 28, 1829.

RESOLVED, That Nathaniel Clark, of Limington, Joel Marshall, of Buxton, and Archebald Smith, of Alfred, be a committee, who, with Isaac Mitchell, of Limington, as a surveyor, shall have power to ascertain, survey and mark the dividing line between the town of Hollis and the town of Waterborough, in the county of York, agreeably to the Acts of incorporation of said towns, and to erect thereon suitable monuments to designate it as the true dividing line between said towns: Provided, That one moiety of the charges and expenses of said committee and surveyor shall be paid by said town of Hollis, and the other moiety thereof by said town of Waterborough.

RESOLVED FURTHER, That the chairman of said committee shall give, to the respective Selectmen of said towns, at least seven days notice in writing of the time and place, when and where the committee and surveyor aforesaid will meet, for the purpose of entering upon the discharge of the duties enjoined upon them by this Resolve.

CHAP. 6.

Resolve in favor of Nicholas Pierce.

Approved February 5, 1829.

RESOLVED, That there be paid out of the Treasury of the State to Nicholas Pierce, of Limerick, in the county of York, four dollars and fifty cents per month, as a pension for disability, by reason of a wound received in his right hand, while in the militia service; to be computed from the first day of February, eighteen hundreed and twenty-nine, for the term of three years, if he so long live.

BE IT FURTHER RESOLVED, That a Resolve in favor of said Nicholas Pierce, passed the ninth day of February, eighteen hundred and twenty-seven, shall be, and remain in force until the first day of February, eighteen hundred and twenty-nine, and no longer, any thing in said Resolve to the contrary notwithstanding.
