and kept open, for the convenience of boats, floats and gondolas that may have occasion to pass under said bridge: *Provided also*, That the inhabitants of the town of Freeport shall at their annual meeting in the months of March, April, or September next, or at any other meeting legally called for the purpose, between the annual meeting in September and the first day of January next, by a majority of votes of the voters present, give their assent to the provisions of this Bill.



## CHAP. 107.

AN ACT to change the names of certain persons.

Approved March 16, 1830.

Names changed.

*BE it enacted by the Senate and House of Representatives, in Legislature assembled*, That Shadrach Pike, of Cornish, in the county of York, shall be allowed to take the name of Harrison Wallice Pike; that Abry Murry, of Waterborough, in the county of York, shall be allowed to take the name of Sabra Hobbs; that Asa Heath Seavy of Portland, in the county of Cumberland, shall be allowed to take the name of Marcian Seavy; that Ruth Scribner, of Portland, in the county of Cumberland, shall be allowed to take the name of Ruth Coffin; that Henry Ilsley, of Westbrook, in the county of Cumberland, shall be allowed to take the name of Henry Jones Ilsley; that Paul Raymond, of Brunswick, in the county of Cumberland, shall be allowed to take the name of Henry Clay Raymond; that Job Winslow Austin, of Pownal, in the county of Cumberland, shall be allowed to take the name of Winslow Austin; that William Heddean, of Bath in the county of Lincoln, shall be allowed to take

the name of John Hayden ; that Artemas Smith, of Brunswick, in the county of Cumberland, shall be allowed to take the name of Artemas Curtis Smith ; that Jonathan Ray, of Green, in the county of Kennebec, shall be allowed to take the name of Greenleaf Ray ; that Simeon Milliken, Junr. of Mount Desert, in the county of Hancock shall be allowed to take the name of Simeon Junivar Milliken ; that Moses Parker Wormwood, Benjamin Wormwood, Sally Wormwood, Emery Newall Wormwood, Nahum Smith Wormwood, William Douglass Wormwood, Benjamin Isaac Wormwood, and Charles Baker Wormwood, all of Surry, in the county of Hancock, shall respectively be allowed to take the surname of Wood ; that Jonathan Jones, of Houlton, in the county of Washington, shall be allowed to take the name of Andrew Paul Jones ; that Bowen Turner, of Wilton, in the county of Kennebec, shall be allowed to take the name of Bowen Turner Dakin ; that Alexander Twambly, of New Portland, in the county of Somerset, shall be allowed to take the name of Alexander Everett ; that Jonathan Holbrook, Junr. of Northport, in the county of Waldo, shall be allowed to take the name of John Francis Holbrook ; that Andrew Roberts of Waterborough, in the county of York, shall be allowed to take the name of Andrew Jackson Roberts ; that Ebenezer Chamberlain, of Brewer, in the county of Penobscot, shall be allowed to take the name of Ebenezer Mattoon Chamberlain : And said persons shall in future, be respectively known and called by the name which they are respectively allowed to take as aforesaid; and the same shall be considered as their only proper names.
