RESOLVES

TENTH LEGISLATURE,

OF THE

STATE OF MAINE,

PASSED AT THE SESSION,

WHICH COMMENCED ON THE SIXTH DAY OF JANUARY, AND ENDED ON
THE NINETEENTH DAY OF MARCH ONE THOUSAND EIGHT HUN-
DRED AND THIRTY.

RESOLVES.

JANUARY SESSION, 1830.

CHAP. 1.

Resolve in favor of the President, Directors, and Company of the Canal Bank.

Approved March 5, 1830.

RESOLVED, That there be allowed, and paid out of the Treasury of this State, to the President, Directors and Company of the Canal Bank, the sum of one hundred and forty six dollars and seventy six cents, being for interest up to the twentieth day of February instant, on the sum of three thousand six hundred and sixty nine dollars, due from this State to said Bank.

RESOLVED, That the Treasurer of this State, if not in funds to pay the President, Directors and Company of the Canal Bank, the sum of three thousand eight hundred and fifteen dollars and seventy six cents, the amount of debt and interest due from this State to said Corporation, be authorized to give his note therefor, on interest, at the rate of five per cent. per annum, from the twentieth day of February instant.

CHAP. 2.

Resolve in favor of Lemuel Smith and others and of Joseph Treworgy and another.

Approved March 5, 1830.

RESOLVED, That there be paid out of the Treasury of this State to Lemuel Smith, Rowland Carlton, William Staples, Isaac Carter, jun. Moses Eaton and Jonathan Bridges, jun. five hundred and twenty one dollars and ninety three cents, to be in full of their claim upon the State, on account of a failure in the State's title to a reserved lot in the town of Sedgwick, which the said Smith, Carlton and Staples purchased of the State, and for costs of surveying said lot and investigating the title thereof. *Provided*, The said Smith and others shall before, or at the

time of the payment of said sum, quitclaim to the State all the right, title, and interest, which they acquired to said lot by virtue of the State's conveyance of the same to them.

RESOLVED, That there be paid out of the Treasury of the State to Joseph Treworgy and James Chase eleven dollars and seventy cents, to be in full of their claim upon the State on account of a failure in the State's title to a reserved lot in the town of Bluehill, which the said Treworgy and Chase purchased of the State. And the Land Agent is hereby authorized and required to cancel and make void a note of hand of the said Treworgy and Chase for the sum of sixty six dollars, and interest, dated March 15th, 1825, which was given in part of the consideration for said lot, provided, the said Treworgy and Chase shall before, or at the time of the payment of said sum, and the canceling of said note, quitclaim to the State all the right, title, and interest, which they acquired to said lot by virtue of the State's conveyance of the same to them.

CHAP. 3.

Resolve granting a Pension to James Pomroy.

Approved March 5, 1830.

RESOLVED, That there be allowed and paid out of the Treasury of this State, to James Pomroy of Hampden, on account of an injury sustained by him while on Militia duty, one dollar a month, in addition to the sum now allowed said Pomroy, to commence on the first day of February, one thousand eight hundred and thirty.

CHAP. 4.

Resolve in favor of Edward Smith.

Approved March 5, 1830.

RESOLVED, That the Land Agent be, and he is hereby directed to convey by deed for, and in behalf of the State, to Edward Smith of Bangor, Township numbered three in the Seventh Range, and Township numbered five in the Fourth Range, according to a sale made at Bangor, October twenty first, eighteen hundred and twenty nine. *Provided*, Said Smith shall pay, or cause to be paid the sum now due, and give good and sufficient sureties to the satisfaction of said Land Agent, for the payment of the sums which may hereafter become due according to the conditions of the sale aforesaid, within fifteen days from the passage of this Resolve.
