TENTH LEGISLATURE,

OF THE

STATE OF MAINE,

PASSED AT THE SESSION,

WHICH COMMENCED ON THE SIXTH DAY OF JANUARY, AND ENDED ON
THE NINETEENTH DAY OF MARCH ONE THOUSAND EIGHT HUN-
DRED AND THIRTY.

CHAP. 5.

Resolve in favor of Jones Dyer Jun.

Approved March 5, 1830.

RESOLVED, That Jones Dyer, jun. of Calais, in the county of Washington, be, and he hereby is authorized and empowered, at his own proper cost and charge, to demand, recover, collect, and receive from such person or persons as, since October in the year of our Lord one thousand eight hundred and twenty eight, may have cut any timber of any kind, on township number one in the first Range, north of the Bingham purchase, Titcomb's survey, the pay therefor and the same to retain to his own use ; and that he may and shall have and enjoy all the rights which the State of Maine has relative to the same ; and may use the name of the State in all processes and proceedings he may deem necessary in the premises. *Provided*, He pays to the State all the expenses it has incurred relative to said timber so cut, and for which he shall demand payment : *And provided further*, That this Resolve shall not extend to any such timber for which payment has already been received by the State.

RESOLVED, That in every suit, which may be commenced by the said Dyer, by virtue of the foregoing Resolve, it shall be stated in the writ, that the same is sued out by the said Jones Dyer, junior, under the Resolve aforesaid ; and whenever, in any such suit, the defendant shall prevail, judgment shall be entered up for the defendant's costs, against said Dyer, and execution shall issue therefor in the same manner as though the action had been commenced and prosecuted in the name of the said Dyer.

CHAP. 6.

Resolve for the benefit of Isaac Tolman and others.

Approved March 5, 1830.

RESOLVED, That there be paid out of the Treasury of the State to Benjamin Crabtree, to the use and for the benefit of Isaac Tolman, Hanson Tolman, Dennis Conway, Tolman Young, Freeman Hall, Alexander Philbrook, Benjamin Burgess, and Thomas E. Burgess, all of the island of Matinicus in the county of Hancock, the sum of sixty dollars, in full compensation for their services in picking up the dead bodies of six seamen, who belonged to the brig Ann Maria, which was cast away on one of the outer ledges of said island, on the nineteenth day of February, in the year of our Lord eighteen hundred and twenty-eight, and for other services rendered by them in relation thereto.
