Chapter 20.

Resolve in favor of William King.

Approved March 8, 1831.

Resolved; That the Governor and Council of the State of Massachusetts, be, and they hereby are authorized, to examamine and settle the claim of William King, Agent of this State for services performed by him, in prosecuting the Massachusetts Claim, at the War Department in Washington, and to pay the amount due to him from the general fund to be received on the claim aforesaid.

Chapter 31.

Resolve apportioning the Representatives among the several Counties; Towns, Plantations and Classes, at the second apportionment.

Approved March 10, 1831.

Resolved, That hereafter and until another general apportionment, the House of Representatives shall consist of one hundred and eighty six members.

Resolved; That twenty four be apportioned to the County of York in the following manner; each of the towns in said: County shall elect one.

That twenty seven Representatives be apportioned to the County of Cumberland as follows --Portland, four; Scarboro', one; Cape Elizabeth, one; Westbrook, one; Gorham, one; Standish, one; Windham, one; Falmouth, one; Cumberland, one; North Yarmouth, one; Gray and the Gore between Raymond and Gray, one; Raymond and the Capelying between Raymond and Standish, one; New Gloucester, one; Freeport, one; Pownal, one; Durham, one; Danville, one; Poland, and the unincorporated territory between Poland and Raymond, one; Minot, one; Bridgton, one; Brunswick, one; Harpswell, one; Harrison and Otisfield, one; Baldwina and Sebago, one.

To the Speaker of the House of Representatives.
