Senator; the several towns, plantations and unincorporated places, composing the County of Penobscot, shall form the ninth District, and be entitled to elect two Senators; The several towns, plantations and unincorporated places, composing the county of Somerset, shall form the tenth District, and be entitled to elect two Senators; And the several towns, plantations and unincorporated places, composing the County of Oxford, shall form the eleventh District, and be entitled to elect two Senators.

Chapter 49.

Resolve authorizing the Governor and Council to pay the Warden the salary of the subordinate officers of the State Prison.

Approved March 25, 1831.

Resolved, That the Treasurer of the State, be, and hereby is authorized to pay to the Warden, the amount of the Salary of the Deputy Warden, and other subordinate officers of the State Prison quarterly; and said Warden shall be held accountable for and pay the same over to said subordinate officers without delay; and the Governor, with advice of Council is hereby authorized to draw his warrant on the Treasurer accordingly.

Chapter 50.

Resolve granting a pension to David Sevey.

Approved March 25, 1831.

Resolved, That there be paid out of the Treasury of this State, to David Sevey, of East Machias, the sum of thirty-six dollars, it being an omission of his annual pension, for the year next preceding the first day of March eighteen hundred and thirty.

Chapter 51.

Resolve in favor of Samuel Phiney.

Approved March 25, 1831.

Resolved, That there be paid out of the Treasury of this State to Samuel Phiney, the sum of thirty four dollars and fifty cents in full compensation for his time and expenses in

apprehending and committing to Gaol, one John Hatch, charged with felony, and who before conviction was delivered to the authorities of the State of Vermont, by order of the Governor of this State.

Chapter 52.

Resolve providing for the transfer of certain papers from the Treasurer's Office to the Land Office.

Approved March 25, 1831.

Resolved, That the Treasurer of this State be, and hereby is directed to deliver to the Land Agent, sundry notes and executions which are now in his office, and were taken or recovered, on account of the public lands, or the timber cut therefrom, for the purpose of having the same adjusted and paid.

Chapter 53.

Resolve providing for the purchase and distribution of Greenleaf's Reports.

Approved March 25, 1831.

Resolved, That the Secretary of State, be, and he is hereby authorized to purchase three hundred and fifty copies of the sixth volume of Greenleaf's Reports, and to distribute one copy thereof to each town and organized plantation; one copy to each of the Justices of the Supreme Judicial Court, and of the Court of Common Pleas, and to each Judge of Probate; one copy to the Attorney General; one copy to each of the Clerks of the Judicial Courts for the use of their respective Counties; one copy to each of the Colleges in this State, and one copy to the Warden of the State Prison: *Provided*, The same can be obtained for a sum not exceeding two dollars and twenty five cents per volume. And the sum of seven hundred and eighty seven dollars and fifty cents is hereby appropriated for that purpose; for which sum the Governor is hereby authorized, with the advice and consent of the Council, to draw his warrant on the Treasury, when the said copies shall have been deposited in the Secretary's office, for the use of the State.
