SECT. 2. Be it further enacted, That it shall be the duty of the Selectmen of said towns and the Further duty of Assessors of said plantations to notify and hold their and Assessors. meetings for the purpose of examining and comparing said copies of the lists of votes within the time and in the manner, provided in the Constitution of this State and in an act, passed the thirty first day of March in the year of our Lord one thousand eight hundred and thirty one; and also, that said Selectmen and Assessors shall be liable to the same penal-Penalty for negties for a neglect to perform the duties aforesaid, lect of duty. which are provided in and by said Act for a neglect to perform the duties therein specified.

Chapter 3.

Be it enacted by the Senate and House of Representatives, in Legislature assembled, That, Members of in all suits at law in which any Mutual Fire Insur- Monaders of ance Company, incorporated in this State, shall be Insurance Com-a party, any member of such Company may be and competent witnesses. is hereby made a competent witness for or against such company ; Provided there be no objection Proviso. against the admission of said witness, except the interest he may have in said suits by reason of his being a member of such company.

SECT. 1. Be it enacted by the Senate and House of Representatives, in Legislature assem-Jurisdiction of bled, That there be and hereby is ceded and grant-certain lots of Land granted to ed to the United States the jurisdiction of the following described lots of land viz :- One lot or parcel of land, situate, lying and being in St. George in the County of Lincoln, and is part of the tract of land which Samuel Marshall purchased of Lucy Knox, as will appear by her deed to said Marshall, dated the fifteenth day of October, one thousand eight hundred and twelve, reference thereunto being had; and is bounded as follows, viz :-- Beginning at high water mark, at the point called Marshall's point; thence running Northwardly, carrying the full width of the land between high water mark on the Easterly side and the high water mark on the Westerly side of said point, so far as to contain four acres, together with the land from high water mark Also one other certain piece or to low water mark. parcel of land situate, lying and being in Vinalhaven in the County of Hancock, and is on the Southerly of the Fox Islands in said Vinalhaven, and is part
